國家發展委員會資管處副處長莊明芬於107年11月5至6日赴韓國首爾參加亞太地區開放政府夥伴聯盟(Open Government Partnership,簡稱OGP)大會,於11月6日在「運用審議機制建構人民信任」(Using Deliberation to Build Trust with Citizens-OGP Practice Working Group on Open Dialogue and Deliberation, Public Engagement Projects, and Trust Democracy)場次,分享報告「臺灣公共政策網路參與機制」(Online Participation in Public Policy in Taiwan),以及在「閃電短講」Spotlight on Innovationsg場次,分享行政院開放政府聯絡人協作制度(Participation Officer;PO Netowrk)。為期兩天的會議,以促進民主、改善治理及重構信任為主軸與各國OGP會員進行經驗分享與交流。

壹、目的

開放政府夥伴聯盟(OGP)自推動以來秉持一貫精神,致力各國政府的開放 及課責,隨著公民科技的進步,社群團體更積極參與對政府公共政策施政效能 及透明度之監督。由韓國 OGP 於 11 月 5 - 6 日辦理 2018 年亞太區域論壇, 讓各全球 OGP 會員國就目前推動之經驗相互交流,本年以促進民主、改善治 理及重構信任為主題,邀請我國分享推動開放政府之成果,本次會議由國家發 展委員會資訊管理處副處長莊明芬於 11 月 6 日在「運用審議機制建構人民信 任」(Using Deliberation to Build Trust with Citizens-OGP Practice Working Group on Open Dialogue and Deliberation, Public Engagement Projects, and Trust Democracy)場次,報告「臺灣公共政策網路參與機制」 (Online Participation in Public Policy in Taiwan) ·以及在「閃電短講」Spotlight on Innovationsg 場次,分享行政院開放政府聯絡人協作制度(Participation Officer; PO Netowrk)。希望將臺灣近年推動網路參與的相關成果推廣至國 際,藉由促進社群與政府之對話,進而重構對政府與民間之相互信任,共同協 力改善政府施政,提出具社會共識之最佳解法,以確保參與式民主及更好的治 理模式能為人民帶來更好的生活。

過去幾年我國一直有意願加入 OGP,成為聯盟的參與會員之一,亦有具體行動,但未能獲得 OGP 推動委員會成員國的全力支持,惟我國仍持續參與 OGP 舉辦之相關活動,讓各界瞭解我國在踐行開放政府的努力及成果。

貳、過程

開放政府夥伴聯盟(OGP)以「促進民主」、「改善治理」及「重建信任」為主軸,於107年11月5日6日在首爾舉辦2018年亞太區域會議。韓國身為OGP的指導委員會成員,邀請來自亞太地區20多個國家的開放政府代表,分享開放政府經驗,希望藉由政府、民間社群與國際間之合作夥伴關係,促進各界之對話,以促進參與式民主尋求創新方式解決社會問題,藉由改善治理之方式重振民眾對政府的信任。

本會受邀於11月6日分享近幾年開放政府業務之推動成果,報告「臺灣公共政策網路參與機制」。簡報內容涵括vTaiwan 線上討論平臺與開放政府聯絡人協作制度(PO Netowrk),與OGP會員國分享臺灣如何透由網路及PO協作

制度,促進公民參與重構政府與民眾的信任關係,並以2個實際案例-我國「報稅軟體系統協作經驗」及公共政策網路參與平臺提點子首案「癌症細胞免疫療法」,向與會人員呈現參與平臺的具體成效以及政府如何建構標準作業程序,回應民眾的訴求。演講先從我國活躍的公民科技-臺灣零時政府(g0v)談起,公民利用寫程式、將政府資料視覺化、建立公民參與平臺等來進行公民參與並試圖改造政府提高政府運作效率,以及太陽花學運民眾占領立法院,訴求立法過程必需公開透明,為回應風起雲湧的公民運動,政府與社群共同打造了一個讓民眾和政府在同一個平臺上討論政策的vTaiwan,透由vTaiwan,並適度運用開源軟體工具,民眾經過不斷討論並和不同意見的人進行理性溝通,在互相論證之後找出共識。

接著再說明我國公共政策網路參與流程及機制,並探討 PO 協作機制,分享政府與市民攜手共創、共同發想公共政策議題的經驗,在案例介紹部分,特別說明成案「癌症細胞免疫療法」的處理流程,權責機關衛生福利部從瞭解提議者完整訴求,到召開多次利害關係人研商會議,最後進行癌症細胞免疫療法修法公告,乃至於已處理完竣的議題,後續仍觀察其施行成效,再接再厲繼續修法建立管理機制將癌症細胞免疫療法納入常規治療,以加惠更多病患。

在探討 PO 協作機制一節時,輔以「報稅軟體系統協作經驗」的漫畫為例,讓與會者瞭解到,即使在提點子過程中,某些議題附議人數不足未能成案,但如果是立意良善的建議,政府仍會納入考量,積極加以改進,並把提議者找進來一起協作,改善報軟體介面,滿足報稅者的需求,讓報稅軟體變的更好用。PO 制度建立一年多以來,將原本單一部會的能量,串連各部會的 PO 們,將其連結網絡擴大延伸,讓政府可更有效率地處理諸多跨部會的議題,並將溝通的力道內化成為公務人員的職能素養。本次演講將新舊案例共陳,展現出數位平臺以外,背後協作與參與機制的重要性。

隨後,莊副處長亦參加閃電短講,再次單獨論述行政院 PO 協作機制,探討臺灣如何透過跨部會協作,解決施政課題,加速行政創新,同時提升公務人員的職能素養,將溝通的力道展現出來,並 OGP 會員們進行數位治理的實質意見交流。

參、結論與建議

臺灣近幾年來的社會創新、公民科技、開放政府經驗在國際上逐漸被認可,與國際友人的交流除了能將臺灣經驗分享到國際舞台上,也讓我們有更多機會接觸到其他國家的開放政府夥伴聯盟之運作、訂定之行動方案等,藉由與OGP會員國之交流,瞭解公民科技團體的努力成果、並能夠深刻地討論各國開放政府的政策與作為,在會議中彼此互相分享、學習,期能在不同文化背景之下討論出適合各國的在地優化解法。

開放政府夥伴關係於2011年9月20日正式啟動,自當時8個創始政府,至今已有79個OGP參與國和20個地方政府做出了超過3,100項承諾,期待讓政府更加開放。欲申請成為OGP之成員,符合資格之參與國需承諾支持開放政府宣言,以維護公開透明的政府原則。開放政府宣言強調承諾政府應提高透明度、打擊腐敗、賦予公民權力並以新科技增進政府之效能與課責。藉由對OGP開放政府宣言之承諾,致力於營造一個賦權於民及開放的文化,以推進開放及參與式民主的政府。

我國雖因特殊之國際關係未能加入OGP聯盟,但仍可借鏡OGP聯盟對財政透明度、資訊取得、資訊揭露及公民參與等4個關鍵領域指標之衡量作法,除了可審視我國在公開政府腳步上,與國際進行比較,是否與國際接軌,是否尚有改善空間外,亦可持續讓我國在開放政府之路上與國際合作並相互交流。

有關本次出訪之具體建議事項如下:

- 一、 善用臺灣社會創新、公民科技、開放政府等經驗,與世界對話,積極參加各國與開放政府及公民科技有關的研討會,持續參加OGP活動,將臺灣近年所累積網路民主之暖實力擴散出去,提升臺灣的能見度。
- 二、 在現行各類網路參與機制中,持續蒐集公私協作的成功案例,包裝成典

- 範,發揮巧思,製作相關文宣如漫畫、影音短片等,有利行銷傳播,達 到更佳的宣傳效果。
- 三、在適當時機可與我國之公民科技社群討論OGP聯盟所制訂之行動方案 Action Plan·評估其宗旨與推動做法·是否有我國可借鏡之處·以完善我國開放政府的發展藍圖。


Directions for Implementing Online Participation in Public Policy

- To provide those possessing citizenship of the State or those holding a certificate of permanent residency in the State with a Public Policy Online Participation Platform
- Through Participation Platform, people offer creative ideas or policy suggestions concerning the State's public policy, and form consensus by a process allowing registration of support, and to provide government agencies, when formulating major policies or draft laws & regulations, or when implementing major policies, with a means for open discussion of said policies or laws & regulations, so as to gather opinions from all quarters, in order to unify and amplify capacity for effectual governance.




Authorities' response

A proposer may submit a proposal only after the Participation Platform has conducted a one-time authentication of the phone number and email address provided by the proposer.

- 1. Range: Topics are limited to affairs and business related the Executive Yuan and its subordinates.
- 2. The initiator can choose up to three authorities which should be responsible to the petition.
- 3. A proposer may choose to make use of the "proposal assistance" to help polish the title or content of a proposal.
- 1. The Participation
 Platform administrative
 authority shall conduct
 the review in
 accordance with the
 substance of a proposal,
 when necessary may
 invite the responsible
 authorities to assist the
 review, and as a rule
 shall carry out the
 review procedure within
 three working days.
- 2. The designated responsible authorities shall confirm within ten working days.
- 1. All persons possessing citizenship of the State or holding a certificate of permanent residency in the State may use a variety of accounts for logging onto the Participation Platform, and after a one-time authentication by means of mobile phone number, register support for a proposal.
- 2. To become established as a case requiring response, a proposal must receive 5,000 registrations of support within 60 days.


- 1. The responsible authorities of each proposal shall pay heed to opinions from all quarters, and shall assess the feasibility of incorporating the proposal into policy implementation.
- 2.The responsible authorities shall have a time period of two months for processing and responding to an established proposal.
- 3. The formal response and explanation may be issued through a press conference, or other means of informing the general public.
 Information on the response shall also be openly posted on the Participation Platform.


Case Flow



Case scenario of "Proposal"

- There were 6,295 proposals by the end of September 2018, 2,941 were entered support-registering procedure, and 156 were established cases. The established rate was 5.3%.
- 33 cases had been taken into account, some of them had participated in the study or had been booked with 35 specifications, 67 had not been collected, and 17 were still under investigation.
- The distribution of established cases was based on health and social security (16.0%), education and sport (14.7%), and transportation and infrastructure (12.8%).



Mind Map






Divergence and Convergence of Idea Lows
