

SOUTHERN AFRICAN DEVELOPMENT COMMUNITY COOPERATION IN ACCREDITATION (SADCA) REPORT TO THE APAC GENERAL ASSEMBLY JUNE 2019

This report covers SADCA activities from March 2018 – May 2019.

1. Status of the Cooperation and Multi-Lateral Mutual Recognition Arrangement Signatories

SADCA currently has a total of 19 Members:

- 3 Arrangement Members (MRA Signatories);
 - MAURITAS, SADCAS, and SANAS
- 8 Ordinary Members;
- 0 Associate Members; and
- 8 Stakeholder Members.

SADCA Membership covers all 15 SADC Member states namely: Angola, Botswana, Democratic Republic of Congo (DRC), Lesotho, Madagascar, Malawi, Mauritius, Mozambique, Namibia, Seychelles, South Africa, Swaziland, United Republic of Tanzania, Zambia and Zimbabwe.

The SADCA MRA was launched on 14 March 2019 for the scopes of Testing and Calibration to ISO/IEC 17025.


