Animal Welfare in WOAH





MAY 2017

- "Animal welfare is a complex and multi-faceted subject with scientific, ethical, economic, cultural, social, religious and political dimensions. It is attracting growing interest from civil society and is one of the priorities of the World Organisation for Animal Health (WOAH)."
- WOAH (the OIE) first agreed to include animal welfare in its strategy in for 2001-2005.
- Standalone Global Animal Welfare Strategy adopted by Members in 2017, to deliver "A world where the welfare of animals is respected, promoted and advanced, in ways that complement the pursuit of animal health, human well-being, socio-economic development and environmental sustainability".
- Terrestrial code definition and standards *animal welfare* is 'the physical and mental state of an animal in relation to the conditions in which it lives and dies.'
- Aquatic code standards for the welfare of farmed fish (excluding ornamental species); advocates appropriate handling and housing environment.




What is the Regional Animal Welfare Strategy – RAWS?

The Regional Animal Welfare Strategy for Asia & the Pacific was developed in 2007 – the first regional plan developed by WOAH

Provides an overarching, agreed framework and guidance for WOAH Members, non-WOAH members and partners in the region when implementing WOAH Standards, and to serve as the basis for the development of Action Plans.

> **Vision**: '*A region where the welfare of animals is respected, promoted and incrementally advanced, simultaneously with the pursuit of progress and socioeconomic development.'*

Asia, the Far East and Oceania 2013–2015




Brief history of the RAWS Asia Pacific



- **2007** RAWS created as an outcome of the 4th OIE Strategic Plan (2006-2010); to emphasise importance of animal welfare, and to influence adoption of the OIE guidelines for animal welfare in the region
- **2008** RAWS endorsed by the OIE 78th General Session (May 2008)
- **2013** Second edition of RAWS released
- 2015 RAWS management was established under the Regional Commission for Asia, the Far East and Oceania and a new RAWS Advisory Group; agreed at the 29th Conference of the WOAH Regional Commission in Ulaanbaatar
- **2022** RAWS Advisory Group was reactivated after COVID-19 pandemic. Regional Commission agreed to new membership and terms of reference at 16 May 2022 meeting
- **2023** New advisory group members endorsed. Action plan under review

Achievements highlights 2016-2023



- 2017 Fiji workshop on emergency preparedness and disaster response / subregional meeting for the Global Frameworks for the Progressive Control of Transboundary Animal Diseases (GF-TADS) with the Pacific Community, WOAH and FAO for the Pacific Islands and Territories
- 2018 survey of animal welfare focal points on training needs and animal welfare issues to support future regional planning under the RAWS
- 2019 Regional training and seminar for Focal Points, Bali, Indonesia
- 2019 ICWE International Coalition for Working Equids session on working equids
- 2020 RAWS News special issue on equine welfare
- 2022 Regional focal point consultation workshop
- 2023 WOAH Webinar on animal welfare standards
- Numerous examples of regional activities by Members (or supported by members) to promote animal welfare, implement WOAH standards and support capacity building, including Malaysia, India, Iran, Bhutan, Republic of Korea, Thailand, China and Fiji.

Revision of RAWS Action Plan

- Reactivated Advisory Group has drafted a 5-year Action Plan to define and track activities that support the implementation of the RAWS.
- This is the third action plan since the RAWS was released.
- Builds on achievements under the previous two plans, addressing gaps and updating actions according to current priorities, knowledge and activities.
- The Action Plan will be circulated to WOAH Delegates and focal points for further comment before it is finalised in early 2024.



Draft Third RAWS Action Plan 2023-2026

Impact (long-term objective)

Enhanced animal welfare alongside progress & socioeconomic development in the region, through a focus on the development & implementation of animal welfare standards for transport, slaughter & killing; capacity building & education; & communication to promote respect & awareness of animal welfare.

Outcome (short to mid-term objectives)

- Promotion & achievement of a high level of understanding & awareness of animal welfare through effective coordination, communication, education, & training.
- 2. Coordinated regional approach to implementation of WOAH animal welfare standards.
- 3. Sustainable improvements in animal welfare, based on regional & international research & development.
- 4. Sustainable mechanisms to coordinate & promote animal welfare programs & priorities.

Priority activities 2023-24

- Restart *RAWS News* for updates on activities and events under RAWS.
- Revise RAWS document.
- Planning for regional animal welfare forum.
- Social media to enhance awareness of the RAWS.
- Support WOAH Members to raise awareness of RAWS through conferences and meetings.
- Support WOAH/ICFAW-OPP Pig management project.
- Promote understanding of and connection on One Health/Welfare nexus.
