PRELIMINARY PROGRAMME

The European Public Health Association (EUPHA) is a multidisciplinary scientific society. It aims to contribute to the improvement of public health in Europe by offering a means for exchanging information and a platform for debate to researchers, policy makers and practitioners in the field of public health and health services research in Europe. Currently, EUPHA has 48 public health organisations as members from 38 countries representing some 10,000 public health experts.

European health systems are undergoing rapid and in some fields fundamental changes. Health policies are slowly being reoriented from a narrow perspective of individual medical care to a broader perspective of population-oriented comprehensive care. Health care sectors are implementing professional systems of quality management. Health service providers are cooperating to develop managed care programmes for chronically ill patient groups and elderly people. At the same time, awareness is growing that an even broader perspective is needed to effectively address the major health challenges in the 21st century. The public health sciences have identified the major socio-cultural, economic, psychosocial and ecological determinants of healthy ageing, health-related quality of life, and chronic diseases. The available evidence calls for integrated policies to reduce social inequality, poverty and unemployment. Collective health promotion and prevention policies are needed to achieve a sustained population-wide health improvement and prevent chronic diseases and accidents.

Health promotion has established itself as a key function of modern public health. It facilitates a culture of social participation, salutogenic quality of life and empowerment by developing health promotion and primary prevention programmes in cities, villages, schools, workplaces and other social settings. Linking strategies of health promotion and health care can improve the quality of life of the community as a whole and of large patient groups, in particular at the interfaces of primary care, hospital care and family or lay care.

State and organisational health policies can be successful if, and only if, they are accompanied by long-term efforts at building structural and operational capacities for a sustainable growth of modern public health. It is critical to develop assets such as health-oriented financing and incentive systems, community and organisational development, good leadership and empowerment. Other important efforts are multi-disciplinary education and training of professionals, and scientific research and knowledge management in fields such as health promotion, prevention and health care, as well as social, clinical and genetic epidemiology. Industrialised countries tend to invest huge amounts of money into capacity building in molecular medicine and biotechnology. Capacity building in the public health sector has, however, been seriously neglected. A long-term policy to build sufficient capacities for innovation and development is a crucial function of modern public health.

The 2005 EUPHA conference in Graz will provide a platform for analysis and debate of current public issues to researchers, policy makers and practitioners. Its aim is to contribute to the development of a modern public health in Europe. Participants are invited to exchange research findings and practical experience and to discuss ongoing or planned work related to five broad fields:

- the directions of public health policies and their impact on the development of polulation health and health systems;
- health promotion and primary prevention programmes in local and social settings as they respond to changing needs of personal and social life and work;
- health care services as they react to the challenges in the fields of disease prevention, quality development and coordination of services at critical interfaces;
- organised efforts to link or integrate health promotion and health care strategies, especially in fields such as clinical prevention, disease management and rehabilitation;
- efforts to build structural and strategic capacities for a sustained population-wide health improvement.

Plenary sessions, workshops, oral presentations and poster sessions will offer stimulating presentations and opportunities for the discussion of current and future issues in modern public health. Ten thematic tracks will guide participants through the conference programme.
