

**MEMORANDUM OF UNDERSTANDING
ON
ACADEMIC AND RESEARCH COOPERATION
BETWEEN
NATIONAL UNIVERSITY OF KAOHSIUNG, REPUBLIC OF CHINA
AND
SEOUL NATIONAL UNIVERSITY, REPUBLIC OF KOREA**

National University of Kaohsiung, the Republic of China, hereafter referred to as NUK and Seoul National University, the Republic of Korea, hereinafter referred to as SNU,

considering their common interest in promoting the mutual cooperation in the area of education and research, both parties, therefore, wish to expand the basis for friendship and co-operative educational exchange and have set forth the following Memorandum of Understanding (MOU).

**ARTICLE I
PURPOSE**

The purpose of this MOU is to develop academic and educational co-operation on the basis of equality and reciprocity and to promote relations and mutual understanding between both universities.

**ARTICLE II
SCOPE OF ACTIVITIES**

Both universities undertake to promote and develop academic co-operation in the following ways:

5. Exchange of academic and administrative staff and students.
6. Co-operation in research and the presentation of its results.
7. Exchange of academic materials, publications and other scientific information.
8. Other educational and academic exchanges to which both universities agree.

**ARTICLE III
FINANCIAL ARRANGEMENT**

3. Both universities agree that all specific arrangements and plans for activities are to be negotiated and are dependent on the availability of funds.
4. Both universities agree to seek financial support from national and international organizations for the cooperative activities to be undertaken as stated under the terms of this MOU.

**ARTICLE IV
AGREEMENT OF IMPLEMENTATION**

A detailed description of the scope of activities shall be defined in an Agreement of Implementation, which constitutes an integral part of this MOU.

An Agreement of Implementation will include such items as:

5. Elaboration of the responsibilities of each institution for the agreed upon activity.
6. Schedules for the specific activity.
7. Budgets and sources of financing for each activity.
8. Any other items deemed necessary for the efficient management of the activity.

**ARTICLE V
INTELLECTUAL PROPERTY RIGHTS AND PUBLICATION**

4. NUK and SNU will share all data and research findings, patent rights, copyrights, and other intellectual property rights to any discoveries, inventions and products resulting from this MOU.
5. Both parties must give written approval for the utilization and publication of the data and research findings.
6. Detailed management of the Intellectual Property Rights and Publication shall be defined in the Agreement of Implementation of each activity.

**ARTICLE VI
SETTLEMENT OF DIFFERENCES**


The differing viewpoints and interpretations of this MOU shall be settled amicably by mutual consultation or negotiation.

**ARTICLE VII
AMENDMENTS, DURATION AND TERMINATION**

4. Amendments to this MOU can only be written by mutual consent of the two parties.
5. This MOU shall be in effect from the date of its signing and be valid for the duration of five years from that date, and will be automatically renewed on an annual basis thereafter, unless terminated or replaced with a new MOU.
6. This MOU may be terminated by either party by written notice at least 6 (six) months in advance. In case the MOU ceases to be in effect of account of its termination, this shall not affect the completion of existing activities as agreed upon in the Agreement of Implementation.


This MOU is written in English in 2 (two) copies, both are authentic. As witness to their consent to this MOU, the appropriate authorities hereunto provide their signatures.

LETTER OF INTENT
FOR COOPERATION BETWEEN
KOREA UNIVERSITY
AND
NATIONAL UNIVERSITY OF KAOHSIUNG

In order to develop academic exchange and cooperation in education and research between the two universities, Korea University and the National University of Kaohsiung mutually agree to sign this letter of intent.

1. Based on the principles of respect for each other's independence and of mutual benefit, the two universities will work towards carrying out the following activities:
 - (1) Exchange of students
 - (2) Exchange of faculty members and staff
 - (3) Exchange of scientific materials, publications and information
 - (4) Joint research and research meetings


2. In order to carry out the above-mentioned activities, detailed work plans are to be developed after consultation between the two universities.

3. This agreement is valid for a period of 3 (three) years from the date of signature and will be automatically extended if no party raises objections, in writing, prior to the end of the term.

4. Revisions to this agreement may be made upon the mutual consent of the two universities.


5. Each party will keep a copy of this letter of intent.
