II. Annotations to the provisional agenda

1. Opening of the session

1. The twenty-sixth session of the Subsidiary Body for Scientific and Technological Advice (SBSTA) is scheduled to be opened by the Chair on Monday, 7 May 2007.

2. Organizational matters

- (a) Adoption of the agenda
- 2. The provisional agenda for the session will be presented for adoption.

- (b) <u>Organization of the work of the session</u>
- 3. *Background*: The Subsidiary Body for Implementation (SBI), at its twenty-fourth session, recommended that meetings should normally end by 6 p.m. but may, in exceptional circumstances, continue to no later than 9 p.m. The twenty-sixth session of the SBSTA will be organized on this basis. Priority will be given to the most urgent issues. Items that are not concluded at this session will be forwarded to the SBSTA at its twenty-seventh session (December 2007).
- 4. To maximize the use of meeting time, the chair of the SBSTA will, where possible and appropriate, propose that negotiating group co-chairs facilitate agreement by tabling initial draft conclusions at the first meeting of the negotiating groups to be established, based on relevant submissions and statements made during plenary meetings, taking into account any previous negotiations and/or conclusions. Representatives of Parties and international organizations are requested to keep their oral statements as brief as possible. Those wishing to make a written statement available should bring copies for distribution.
- 5. *Action*: The SBSTA will be invited to agree upon the organization of the work of the session.

- 6. Parties are invited to refer to the overview of the session posted on the UNFCCC website and to consult the Daily Programme, published during the session, for a detailed and up-to-date schedule of the work of the SBSTA.
- 7. Parties are also invited to take into account information contained in document FCCC/SB/2007/INF.2, on the relationship of various provisions of the Mauritius Strategy to the work of the Convention and its Kyoto Protocol, when considering relevant agenda items.

3. Nairobi work programme on impacts, vulnerability and adaptation to climate change

- 8. *Background*: At its twenty-fifth session, the SBSTA agreed to implement the work programme through the activities contained in its conclusions (FCCC/SBSTA/2006/11).
- 9. At the same session, the SBSTA requested the secretariat, under the guidance of the Chair of the SBSTA, to report, at its twenty-sixth session (May 2007) on progress made in implementing the Nairobi work programme. It also invited relevant organizations and other stakeholders to participate in the implementation of the activities of the programme. The SBSTA further urged them to undertake their own activities in support of the objective and themes identified in decision 2/CP.11 and to share the outcomes of these activities with the SBSTA at subsequent sessions, as appropriate.
- 10. The SBSTA also invited Parties and relevant organizations to submit to the secretariat, by 23 February 2007, information on their relevant programmes, activities and views on the issues relating to climate related risks and extreme events, which would serve as input to the workshop on this matter to be held before SBSTA 27.¹
- 11. *Action:* The SBSTA will be invited to take note of an oral report from the secretariat on progress made in implementing the work programme, including planned activities and any information from relevant organizations on their activities in support of the Nairobi work programme.

4. Development and transfer of technologies

- 12. *Background:* At its twenty-fifth session, the SBSTA considered possible actions for enhancing the implementation of the technology transfer framework (FCCC/SBSTA/2006/5, annex II) and views from Parties on the review of the Expert Group for Technology Transfer (EGTT) (FCCC/SBSTA/2006/MISC.10). Parties did not complete their consideration of these issues and decided to forward a draft decision (in square brackets) to the Conference of the Parties (COP) (FCCC/SBSTA/2006/11, annex II).
- 13. The COP, by its decision 5/CP.12, decided to extend the mandate of the EGTT by one year, including its current membership, and to forward the text of the above-mentioned draft decision to the SBSTA for consideration at its twenty-sixth session, with a view to recommending a draft decision on this matter for adoption by the COP at its thirteenth session.

- 14. The COP, by its decision 6/CP.11, requested the secretariat to organize a senior-level round-table discussion between Parties, international financing organizations, the private sector and other stakeholders at SBSTA 25 to discuss and exchange views on issues, experiences and lessons learned, and strategies for short-, medium- and long-term international technology cooperation and partnerships in the development, deployment, diffusion and transfer of environmentally sound technologies and know-how to enable more informed decisions on actions in the future. As requested by the SBSTA at its twenty-fifth session, the secretariat prepared the report of the round-table discussion (FCCC/SBSTA/2007/2).
- 15. The SBSTA, at its twenty-fifth session, requested the secretariat, in collaboration with the United Nations Industrial Development Organization, the United Nations Environment Programme, the United Nations Development Programme and the EGTT, to undertake specific follow-up activities, including to organize a seminar for the technology information centres participating in the pilot project to share lessons learned from the pilot project on networking. The report on the seminar is contained in document FCCC/SBSTA/2007/INF.1.
- 16. *Action*: The SBSTA will be invited to consider the draft decision mentioned in paragraph 12 above, with a view to recommending a draft decision for adoption by the COP at its thirteenth session. It may also wish to take note of the documents prepared for the session and to determine any further actions arising from them.

5. Reducing emissions from deforestation in developing countries

- 17. *Background*: The SBSTA, at its twenty-fifth session, requested the secretariat to organize a second workshop on this issue before its twenty-sixth session. This workshop will be held in Cairns, Australia, from 7 to 9 March 2007. The SBSTA decided to continue discussing the range of topics considered at the first workshop,² held in Rome, Italy, from 30 August to 1 September 2006, including the submissions of views on a range of topics by Parties and accredited observers, at the second workshop, that will focus on: the discussions of ongoing and potential policy approaches and positive incentives, and technical and methodological requirements related to their implementation; assessment of results and their reliability; and improving the understanding of reducing emissions from deforestation in developing countries. The reports of the two workshops are contained in documents FCCC/SBSTA/2006/10 and FCCC/SBSTA/2007/3.
- 18. To facilitate discussions at the second workshop, the SBSTA invited Parties and accredited observers to submit to the secretariat their views on the topics to be addressed at the second workshop. It also invited Parties, in their submissions, to consider, as appropriate, relevant provisions of other conventions and the work of multilateral organizations. The SBSTA requested the secretariat to make these submissions available for discussion at the workshop and compile this information for consideration at its twenty-sixth session. The submissions by Parties and accredited intergovernmental

organizations are contained in documents FCCC/SBSTA/2007/MISC.2 and FCCC/SBSTA/2007/MISC.3, and the submissions by accredited non-governmental organizations are posted on the UNFCCC website³.

- 19. The SBSTA also requested the secretariat to prepare a report on the second workshop for consideration at its twenty-sixth session.
- 20. *Action*: The SBSTA will be invited to:
 - (a) Consider the views and information submitted by Parties, accredited intergovernmental organizations and accredited non-governmental organizations;
 - (b) Consider the two workshop reports and relevant elements that could be included in the report on its twenty-seventh session on this agenda item, including any recommendations to the Conference of the Parties at its thirteenth session;
 - (c) Consider the process forward, including the possible need for background papers, a third workshop, expert meetings and/ or informal consultations before the twenty-seventh session of the SBSTA.

6. Research and systematic observation

- 21. *Background:* During SBSTA 24, a special side event was held during which representatives from regional and international climate change research programmes provided information on their current activities to address the research needs of the Convention. At that same session, the SBSTA invited these programmes to provide, together or separately, to the SBSTA before its twenty-fifth session, a short summary report or reports drawing on the special side event, including identification of any gaps in their research programmes with respect to the research needs of the Convention, as viewed by Parties (for example in document FCCC/SBSTA/2006/INF.2), and considering options for addressing these needs. The secretariat has received two such summary reports, which were made available to the SBSTA at its twenty-fifth session as document FCCC/SBSTA/2006/MISC.15.
- 22. At its twenty-fourth session, the SBSTA also agreed to explore how it might facilitate a more effective dialogue between Parties and the regional and international climate change research programmes in the context of decision 9/CP.11. Parties and these programmes were invited to submit, by 23 February 2007, their views on this subject, for consideration by the SBSTA at its twenty-sixth session. These views are contained in documents FCCC/SBSTA/2007/MISC.7 and FCCC/SBSTA/2007/MISC.8.
- 23. To further facilitate the development of such a dialogue, the SBSTA asked the secretariat to organize a meeting for an informal discussion among Parties to take place at SBSTA 26, and to invite the

representatives of the regional and international climate change research programmes and the IPCC to participate. This meeting is tentatively scheduled for 8 May 2007.

- 24. As regards systematic observation, the SBSTA, at its twenty-third session, welcomed the efforts by the Global Terrestrial Observing System (GTOS) secretariat to develop a framework for the preparation of guidance materials, standards and reporting guidelines for terrestrial observing systems for climate, and encouraged the GTOS to continue its work. It also called on the GTOS secretariat to assess the status of the development of standards for each of the essential climate variables in the terrestrial domain, and invited the GTOS secretariat to report on its progress at SBSTA 26. The report by the GTOS secretariat is contained in document FCCC/SBSTA/2007/MISC.6. In keeping with the recommendation of the SBI at its twenty-fourth session⁴ that the topics under the research and systematic observation item be differentiated and considered by the SBSTA on an alternating basis, the SBSTA will consider this document its twenty-seventh session, when it addresses matters related to systematic observation.
- 25. *Action*: The SBSTA will be invited to consider the information provided and to identify possible further actions to facilitate implementation of decision 9/CP.11, including exploring how a more effective dialogue between Parties and the regional and international climate change research programmes on the research needs of the Convention may be facilitated by the SBSTA.

7. Methodological issues under the Convention

- (a) <u>Intergovernmental Panel on Climate Change guidelines for national greenhouse gas inventories</u>
- 26. Background: The SBSTA, at its seventeenth session,⁵ invited the IPCC to revise the Revised 1996 IPCC Guidelines for National Greenhouse Gas Inventories, taking into consideration relevant work under the Convention and its Kyoto Protocol, and to complete the work by early 2006. The 2006 IPCC Guidelines for National Greenhouse Gas Inventories were made available at SBSTA 24 as requested.

- 27. At its twenty-third session, 6 the SBSTA agreed to consider, at its twenty-fourth session, concurrent with its consideration of the 2006 IPCC Guidelines for National Greenhouse Gas Inventories, the way in which emissions and removals currently covered in the land use, land-use change and forestry (LULUCF) and agriculture sectors will be presented in the national totals; inventory issues associated with biomass burning and natural disturbances as they relate to reporting under the Convention; and the implications for reporting of the conversion to carbon dioxide in the atmosphere of methane, carbon monoxide and non-methane volatile organic compounds emitted in association with carbon stock changes.
- 28. The SBSTA initiated consideration of these issues at its twenty-fourth session, but was unable to complete. The SBSTA therefore decided to continue its consideration of the 2006 IPCC Guidelines for National Greenhouse Gas Inventories and of the issues in paragraph 27 above at its twenty-sixth session.
- 29. The SBSTA, at its twenty-fourth session, and in the context of the discussion of the 2006 IPCC Guidelines for National Greenhouse Gas Inventories, addressed issues relating to harvested wood products. It invited Parties in a position to do so to voluntarily report on harvested wood products in their national inventories in a manner consistent with current UNFCCC reporting guidelines. The SBSTA decided to continue, at its twenty-sixth session, its consideration of issues relating to reporting on harvested wood products in the context of its consideration of the 2006 IPCC Guidelines for National Greenhouse Gas Inventories, and of other issues relating to these guidelines.
- 30. *Action*: The SBSTA is invited to continue its consideration of these issues with a view to taking action, if appropriate.
- (b) <u>Greenhouse gas data interface</u>
- 31. *Background*: At its twenty-fourth session, the SBSTA recalled its request to the secretariat (FCCC/SBSTA/2004/13, paragraph 58) to develop a simple and user-friendly interface available on the UNFCCC website and on CD-ROM to assist Parties to search and sort available greenhouse gas inventory data. The SBSTA requested the secretariat to present the data interface to Parties by the end of 2006 with a view to making it fully operational before the first sessional period in 2007. The SBSTA also invited Parties to provide to the secretariat, by 23 February 2007, their views on the data interface, on possible improvements, including the extent of its scope and coverage, and on next steps in this work. The SBSTA decided to continue consideration of this matter at its twenty-sixth session. Responding to the request by Parties, in December 2006 the secretariat posted a presentation of the main design features of the data interface on the secretariat's greenhouse gas emissions web page.⁷
- 32. *Action*: The SBSTA is invited to consider the information contained in document FCCC/SBSTA/2007/MISC.9 and to decide on further steps on this matter.

- (c) Emissions from fuel used for international aviation and maritime transport
- 33. *Background*: At SBSTA 25,⁸ Parties did not complete their consideration of issues under this agenda sub-item and agreed to continue their consideration of this matter at SBSTA 26.

34. Action: The SBSTA will be invited to determine if agreement can be found on these issues, taking into account the exchange of views at previous SBSTA sessions.

8. Methodological issues under the Kyoto Protocol

- (a) Implications of the establishment of new hydrochlorofluorocarbon-22 (HCFC-22) facilities seeking to obtain certified emission reductions for the destruction of hydrofluorocarbon-23 (HFC-23)
- 35. *Background*: The COP, by its decision 12/CP.10, requested the SBSTA to develop a recommendation relating to the implications of the establishment of new HCFC-22 facilities by project participants who seek to obtain certified emission reductions (CERs) for the destruction of HFC-23 in order to achieve the objectives of the Montreal Protocol on Substances that Deplete the Ozone Layer.
- 36. The Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP), by its decision 8/CMP.1, agreed on definitions that should apply to new HCFC-22 facilities and that issuing certified emissions reductions for HFC-23 destruction at new HCFC-22 facilities could lead to higher global production of HCFC-22 and/or HFC-23 than would otherwise occur and that the clean development mechanism should not lead to such increases. Further, the SBSTA, at its twenty-fourth session, invited Parties, admitted observers and relevant intergovernmental organizations to submit inputs elaborating practical solutions to address the implications of this situation (FCCC/SBSTA/2006/MISC.11).
- 37. The SBSTA, at its twenty-fifth session, considered three options that were proposed by Parties, which were partly based on the submissions referred to in paragraph 36 above. These options included (i) significantly discounting CERs for such projects, (ii) crediting emission reductions for project activities that substitute the use of HCFC-22 and (iii) issuing CERs for a project activity to entities other than the operator of the HCFC-22 installation who then reimburse the operator the costs of HFC-23 destruction, and add a small incentive for carrying out the project activities. The implications of decision XVIII/12 (paragraphs 2 and 3) of the Meeting of the Parties to the Montreal Protocol on Substances that Deplete the Ozone Layer were also considered. The SBSTA could not conclude its consideration of the issue.
- 38. *Action*: The SBSTA will be invited to further consider the issue, building on the work done at SBSTA 25, with a view to preparing a draft decision containing guidance to the Executive Board of the clean development mechanism (CDM) for adoption by the CMP at its third session.
- (b) <u>Implications of possible changes to the limit for small-scale afforestation and reforestation clean development mechanism project activities</u>
- 39. *Background*: The CMP, by its decision 1/CMP.2, requested Parties, intergovernmental organizations and non-governmental organizations to submit their views to the secretariat, by 23 February 2007, on the implications of possible changes to the limit established for small-scale afforestation and reforestation CDM project activities in paragraph 1 (i) of the annex to decision 5/CMP.1, for consideration by the SBSTA at its twenty-sixth session. The submissions from Parties and accredited intergovernmental organizations are contained in document FCCC/SBSTA/2007/MISC.1. Submissions from other intergovernmental organizations and from non-governmental organizations will be available on the UNFCCC website.⁹

40. *Action*: The SBSTA will be invited to consider the views of Parties, inter-governmental organizations and non-governmental organizations with a view to preparing a draft decision containing guidance to the Executive Board of the CDM for adoption by the CMP at its third session.

9. Scientific, technical and socio-economic aspects of mitigation of climate change

- 41. *Background*: At SBSTA 23,¹⁰ Parties agreed to continue work on the scientific, technical and socio-economic aspects of mitigation, and to focus on exchanging information and sharing experiences and views among Parties on practical opportunities and solutions to facilitate the implementation of the Convention as mandated by decision 10/CP.9. In this context, the SBSTA requested the secretariat to organize workshops at each of its next four sessions. The second,¹¹ third and fourth of these workshops will take place during SBSTA 26 and will focus on issues relating to: urban planning and development, including transportation; energy efficiency, including industry, and residential and commercial end-use; and power generation, including clean fossil fuels and renewable energy.
- 42. At the same session, ¹² the SBSTA agreed to take stock of its work on the scientific, technical and socio-economic aspects of mitigation of climate change at its twenty-seventh session, and to report to the COP at its thirteenth session.
- 43. *Action*: The Chair of the SBSTA will provide an oral report on the issues addressed during the three workshops mentioned in paragraph 41 above. The SBSTA will take stock of its work on mitigation at its twenty-seventh session.

10. Matters relating to Article 2, paragraph 3, of the Kyoto Protocol

- 44. *Background*: At SBSTA 25, ¹³ Parties did not complete their consideration of issues under this agenda sub-item and agreed to continue their consideration of this matter at SBSTA 26.
- 45. *Action*: The SBSTA will be invited to determine if agreement can be found on these issues, taking into account the exchange of views at previous SBSTA sessions.

11. Cooperation with relevant international organizations

- 46. *Background*: The SBSTA, at its fourteenth session, ¹⁴ requested the secretariat to report periodically on the activities of the Joint Liaison Group (JLG) between the three Rio conventions. The secretariat will provide an oral report on these activities.
- 47. At its twenty-fourth session, the SBSTA requested the secretariat to report to it at its twenty-sixth session, for the information of Parties, on the outcome of the fifteenth session of the United Nations Commission on Sustainable Development, which will focus on energy for sustainable development, industrial development, air pollution/atmosphere and climate change.

In accordance with the conclusions of the SBSTA at its twenty-third session, the second workshop should have taken place at SBSTA 25. However, due to time limitations at SBSTA 25 (FCCC/SBSTA/2006/6, para. 6) the workshop will take place during SBSTA 26.

- 48. It is also anticipated that representatives of other conventions, scientific organizations and United Nations bodies will provide information on their activities relevant to the Convention. The secretariat will provide information on on-going collaboration with other organizations and on initiatives to mobilize the widest possible support among United Nations bodies for the implementation of the Convention and its Kyoto Protocol.
- 49. The secretariat has organized in cooperation with the IPCC an in-depth briefing during the sessions of the subsidiary bodies on the contributions of the three IPCC working groups to the Fourth Assessment Report.
- 50. *Action*: The SBSTA will be invited to consider the information provided to determine what further action is required, as appropriate.

12. Other matters

51. Other matters arising during the session will be taken up by the SBSTA under this item.

13. Report on the session

- 52. *Background*: A draft report on the work of the session will be prepared for adoption by the SBSTA at the end of the session.
- 53. *Action*: The SBSTA will be invited to adopt the draft report and authorize the Rapporteur to complete the report after the session, under the guidance of the Chair and with the assistance of the secretariat.
