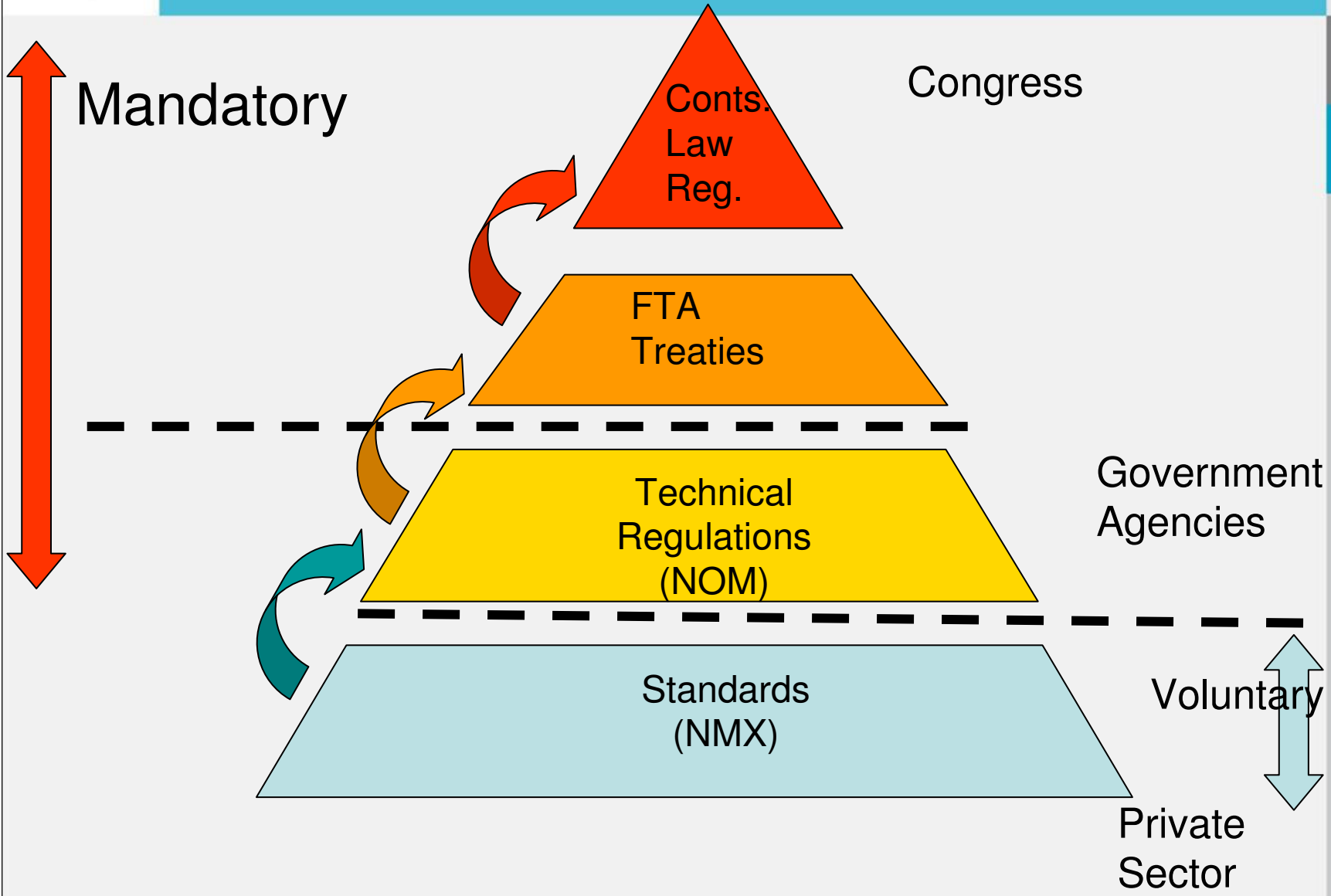

International instruments for Mutual Recognition to the results of conformity assessment.

- **¿Who subscribes them?**
  - **The Ministry of Economy ,**
    - By the ministry itself or upon request of a different authority.
    - Accreditation entities
    - Accredited persons



# Requierments MRA

- **The Ministry of Economy shall always grant its agreement.**
- When the standards are responsibility of the Ministry of Economy, it shall grant its approval.
- Requirements to achieve a MRA (specified on LFMN)
  - Between Same Entities, same core business, etc.
  - Notification of intent
  - Comments to Deputy International trade negotiation Ministry of Economy
  - Agree of Government Agency on charge of NOM, if apply.
- Applying NOM and NMX on EEE
  - Saefy
  - Electromagnetic Compatibility
  - Energy efficiency
