Step-1: Review current situation to identify;

(1) Strengths

(2) Major problems and causes

1) Field level, 2) Local VS level,

3) Central VS, 4) Regional level

Step-2: List five problems to address

Step-3: Identify items for solution

**Step-4: Identify inputs for solution
(National/Regional/International level)**

Examples of Main Goals

1. Legislation support
2. Awareness of diseases at field level, including education of farmers on animal health
3. Contact with farmers to collect disease information
4. Early detection at field level
5. Appropriate diagnostic and surveillance capacity at local and national level
6. Early notification from farms to local VS
7. Transparent & timely notification from local VS to National VS
8. Compensation mechanism
9. Deployment of human resources at local & national level
10. Regional information networking

Examples of principal measures

1. Notification

<Control Measures>

1. Culling,
2. Movement restriction,
3. Disinfection
4. Disposal of contaminated objects (incineration, burial)
5. Vaccination,
6. On-site inspection,
7. Testing
8. Surveillance,
9. Border control (quarantine),
10. Compensation

<Prevention Measures>

1. Surveillance,
2. Testing,
3. Vaccination
4. On-site inspection,
5. Border control (quarantine)

- **Step-2: (Strengths, Problems/Causes)**
 1. Identify strengths, major problems and causes related to legislation and its enforcement.
 2. Identify major gaps between control/prevention measures to be taken and their implementation.
- **Step-3: (Solution)**

Identify possible and practical items for solution
- **Step-4: (Inputs)**

Necessary input to achieve goals (efforts, cooperation, etc.)

(1) National level, (2) Regional level, (3) International Level
