壹、目的

本次到日本的目的主要為代表國家秘書處出席 UMAP 2010 年第一次理事國會議並參加副校長論壇。由於本次理事國會議將進行 2011-2015 年國際秘書處駐在國與 2011-2012 年主席國的遴選,而我國亦準備於會中爭取成為 2011-2015 年國際秘書處駐在國。

UMAP (University Mobility in Asia and the Pacific,亞太大學交流協會)成立於 1993年,是由亞太地區官方與非官方(尤指各大專院校之聯合組織)高等教育組織代表所自發組成的協會,但以每個國家(地區)僅有一席為原則。其成立之目標為:藉著加強亞太地區高等教育機構之間的合作以及各大學彼此間學生與教職員的交流 (mobility of university students and staff),以期能達到亞太地區不同國家與不同地方之間文化、經濟、社會制度的相互瞭解。

貳、過程

2010年 UMAP 第一次理事國會議 (Board Meeting 1/2010) 及各委員會會議於 3 月 3 至 5 日在日本東京 (Tokyo) 私學會館 (Arcadia Ichigaya Hotel) 舉行。整個會議的行程如下:

本次會議共有來自 Brunei Darussalam (汶萊)、Japan (日本)、Macau (澳門)、Malaysia (馬來西亞)、Mexico (墨西哥)、Mongolia (蒙古)、Philippines (菲律賓)、Taiwan、Thailand (泰國)、Vietnam (越南)等 10 個國家 (地區)的代表參加此次會議。會議過程中,除全程參與各個委員會的討論外,並分別擔任 Committee on Models and Roles of Member Secretariats 及 UMAP Vice President Forum Coordination Committee 的主席。

在此次會議中最重要的任務為在 3 月 4 日下午的 Committee on Chair Election and International Secretariat 中,爭取我國成為 2011-2015 年 UMAP 國際秘書處的駐在國;除我國有意爭取 IS 外,菲律賓亦表達極力爭取的意願。會議中除充分行銷我國外,並就國際秘書處未來的角色提出「From MOBILITY to VICTOR」($\underline{\mathbf{V}}$ is ibility, $\underline{\mathbf{I}}$ ntegration, $\underline{\mathbf{C}}$ ollaboration, $\underline{\mathbf{T}}$ enacious, $\underline{\mathbf{O}}$ pportunity, $\underline{\mathbf{R}}$ epresentation)的願景,獲得委員會的高度肯定,並順利獲得提名至隔日的 Board Meeting 上正式討論。

3月5日下午的 Board Meeting 中,我國再次於會中報告籌備執行 UMAP 國際秘書處的計畫,會中獲得各出席委員國代表的肯定,終於無異議通過我國成為2011-2015年 UMAP 國際秘書處的駐在國。此外,於 Board Meeting 中亦決議,6月24-26日將在泰國曼谷召開國際會議,我國亦爭取於會議中進行專題報告;10月11日將在 Brunei Darussalam (汶萊)召開本年度的第二次 Board Meeting。

參、心得

針對此次出席 UMAP 2010 年第一次理事國會議及副校長論壇等會議,主要有以下心得:

- (一)在爭取我國成為 2011-2015 年 UMAP 國際秘書處的駐在國計畫的過程中,事前的與各會員國(地區)及主席國(日本)的良好互動,是我國此次能順利爭取到 2011-2015 年 UMAP IS 的重要關鍵之一。
- (二)在參與 UMAP 會議前,本校(國家秘書處)與教育部長官的充份討論,與對未來計畫執行的腹案,亦是我國能此次能順利爭取到 2011-2015 年 UMAP IS 的重要關鍵之一。
- (三)從參與 UMAP 的會議過程中發現,UMAP 所積極推動的「學分轉換」(給予、承認)系統(UCTS, University Credit Transfer Scheme)¹與國內持續推動的「工程及科技教育認證」(IEET, Institute of Engineering Education Taiwan,中華工程教育學會)²、「商管

² 中華工程教育學會(Institute of Engineering Education Taiwan),簡稱 IEET,為獲得國際認可的臺灣 地區工程及科技教育認證工作執行單位,依照「華盛頓協定(Washington Accord,簡稱 WA)」 訂立「工程及科技教育認證規範(AC 2004+)」,作為檢視各認證單位之標準。認證的目的在於 檢視受認證系所是否達成其自訂之教育目標及核心能力,以及是否能有效執行持續改進機制。 IEET 認證的四大特色:「成果導向、持續改進、產學互動、國際接軌」。獲得認證通過之系所畢

國際認證」(AACSB, The Association to Advance Collegiate Schools of Business)³、「數位學習課程認證」等制度是可以充份接軌的。

(四)在 UMAP 的組織中,對於 Vice President Forum 相當地看重,目前我國與馬來西亞是 Vice President Forum Coordination Committee 的 co-chair,未來如何扮演更積極的角色,應是可以努力的方向之一。

肆、建議事項

針對此次出國,則有以下建議:

- (一)對於 2011-2015 年 UMAP 國際秘書處的未來運作,及國家秘書處與國際秘書處的統合,需積極進行籌備的工作,並與教育部長官充份討論。
- (二)針對 UMAP 所積極推動的「學分轉換」(給予、承認)系統(UCTS)如何與中華工程教育學會合作,建議可以進行討論。
- (三)6月24-26日將在泰國曼谷召開的 UMAP 年度國際會議,我國的專題報告建議 以國內推動的「工程及科技教育認證」經驗進行報告,以擴大我國在亞太地區高等教育的 影響力。
 - (四)參酌 UMAP 的副校長論壇,建議組織國內大學校院的副校長交流組織。
