內容摘要:

桃園國際機場股份有限公司為辦理桃園國際機場規畫之各項重大建設,包括本機場園區綱要計畫內規劃之第三航廈、第三跑道及衛星廊廳等發展桃園航空城之核心重大建設,同時提昇桃園機場發展航空城之國際能見度,並與國際航空城市接軌,實有必要積極走入國際,將桃園國際機場發展為國際一流之航空城市的遠景與使命告諸海外,本公司首度規劃出席由 ACI 主辦之世界航空城論壇及展覽,希望能與國際機場專業人士交流機場開發與航空城發展的經驗與想法。

與此同時,美國達拉斯機場係美國中部疏運美國本土旅客及中南美洲轉運之重要機場。機場成立於1974年,目前營運中共有七條跑道,機場園區總面積為7,318公頃(約為桃園機場園區之6.4倍),2010年旅客量為5,690萬人次,其中以國內旅客為大宗,約佔總旅次之90%。此次本公司應達拉斯機場公司(Dallas Fort Worth International Airport)邀請,於出席論壇活動後,順道前往參訪該機場發展航空城暨相關場站設施現況,並首度交換雙方締結為姊妹機場之相關構想。

壹、 目的

世界航空城展覽暨論壇大會主席 Prof. John D Kasarda 指出, 21 世紀的機場正在體驗全新、前所未有的轉變,機場不再只是機場,而是演變為一座航空城市。機場從過去單純只是提供航空運輸服務的場所,開始因應旅客需求提供多元化的商業服務,諸如免稅購物、零售、餐飲等。重要的機場如今變成了複合運輸的節點,同時也成為商業、貿易、資訊交換與休閒活動的集散地。因此,飯店、會議中心、貿易與展覽設施、企業商辦、零售商店與各式各樣的文化、娛樂中心紛紛圍繞著機場或在機場內設立。簡單來說,機場儼然成為新的城市發展核心,而航空城聚落的形成將是全球運籌發展運作下的必然結果。

有鑒於此,本公司為辦理桃園國際機場規畫之各項重大建設,包括本機場園區綱要計畫內規劃之第三航廈、第三跑道及衛星廊廳等發展桃園航空城之核心重大建設,同時提昇桃園機場發展航空城之國際能見度,並與國際航空城市接軌,實有必要積極走入國際,將桃園國際機場發展為國際一流之航空城市的遠景與使命告諸海外,本公司首度規劃出席由 ACI 主辦之世界航空城論壇及展覽,希望能與國際機場專業人士交流機場開發與航空城發展的經驗與想法。

參、 Airport cities World Exhibition and Conference 簡介

全球航空城展覽暨論壇係一年一度全球機場的領袖會議,由航空城概念提出者亦為大會主席 Dr. John D. Kasarda 推動,透過舉辦會議的形式,吸引全球機場管理精英、建築師、經濟智庫及地產開發規劃業者齊聚一堂,讓航空到非航空領域專家,作為彼此交流分享商機與未來趨勢的平台。

全球航空城展覽暨論壇同時也作為機場 CEO 展現機場未來發展規劃構想的獨特機會,藉此會議,全球機場發展的關鍵決策者將可見證與彼此激盪出火花,共同分享機場永續經營的秘訣。

每年該會議幾乎吸引約 500 名頂尖機場專業以及 50 家展覽商(包括全球機場單位、航空公司、機場設計規劃業者等),會展期間規劃 2-3 日,自 2002 年起,已先後邀請許多知名國際機場城市主辦,包括匹茲堡機場、杜拜機場、底特律機場、香港赤鱲角機場、法蘭克福機場、達拉斯機場、雅典機場、北京首都機場、曼菲斯機場等,至今已舉辦九屆。2012 年全球航空城論壇將由美國丹佛機場主辦。

肆、 論壇部分

一年一度的世界航空城論壇至今已經將近十年,今年(2011)舉辦地點來到美國航空貨運大城曼菲斯。曼菲斯是美國聯邦快遞總部所在地,曼菲斯機場更曾連續 18 年獲得全球空運貨運吞吐量第一名的重要機場。本次論壇共為期三日,除了本機場公司林鵬良總經理獲邀出席發表演說外,機場公司亦於會 展現場展出桃園機場第一航廈門戶改建計畫、綱要計畫內容及第三航廈計畫等。現場並有許多航空產業界專業人士及官方代表出席與會,論壇主題包括航空城發展策 略與實例研討、機場領袖座談及航空城經營模式、貨運運籌中心的發展、聯外交通運輸、擴大非航空收入、土地開發及財務投資模型等。

林鵬良總經理於 4 月 11 日 (二) 出席 2011 年世界航空城論壇發表演說時,針對桃園機場的全球區位、海空運優勢、航空城發展策略與未來機場園區重大建設計畫等作出完整說明。大會主席亦同時是航空城概念(Aerotropolis) 提出者 Prof. John D Kasarda 教授表示,十分樂見於台灣桃園航空城計畫將成為驅動台灣、甚至是亞太區域經濟發展的關鍵引擎。

此行林總經理首度獲邀在世界航空城論壇中發表演說,一開場 即以台灣與桃園機場之全球地理區位做扼要說明,彰顯台灣在全球 化經濟發展中的關鍵位置。同時,林總經理與現場聽眾分享桃園機場園區與周邊地區的發展遠景,其中包括桃園機場與高鐵青埔車站專區將同步發展成為雙核心的航空城發展策略,以及完整聯外交通路網的規劃等。最後,更揭露桃園機場的長期發展計畫,亦即甫於本年度4月11日獲行政院通過之桃園機場園區綱要計畫藍圖。

論壇首日即由大會主席 Prof. John D. Kasarda 為全球機場管理精英及專業人士簡介航空城概念內容,同時以阿姆斯特丹航空城、華盛頓杜勒斯機場周邊、香港赤鱲角機場、臺灣桃園國際機場及巴拿馬國際機場為例,從歐洲、美國到亞洲的航空城最新規劃或發展現況。




圖:華盛頓機場北方區域發展今非昔比 (1960 vs. 2007)




圖:印度海德拉巴機場園區發展藍圖

從以上案例可以發現歐美與亞洲機場航空城的發展概念略有不同處,由於歐美機場發展歷史已久,航空城及相關商業設施發展並不一定以機場為核心發展,而是沿著以機場為輻輳的機場公路系統向外延伸,許多依賴航空服務或航空產業的企業總部或運籌總部多半會沿著公路設置,並自機場向市區延伸;亞洲區新興機場與航空城規劃則多半將機場園區重新作分區規劃,除了航空業與空、陸側設施外,更將產業發展與商業設施都一併於機場園區內作出區劃。

一座機場的發展除了需要先天地理區位條件與航網構連出便利的空運服務體系外,良好的機場整體規劃與聯外交通更會進一步促進產業聚落的發展,甚而提升該機場於國際地理區位上的能見度與重要性,成為鄰近國家或市場的商務與物流運籌中心,達到該機場與國際區域市場互利雙贏共存的局面。

論壇設計為兩日議程,規劃主題包括機場經營管理-CEO 觀點、機場企業經營模式、貨運及物流中心、航空城運輸系統、航空城計劃設計、環境永續、非航空收入、土地開發與複合式使用、財務與資金籌措之可行性及智慧航空城等議題。完整議程如下表:

除了論壇之外,本次大會主辦單位亦安排 FedEx Global Tour,接待出席貴賓參訪全球最大、最繁忙的貨運機場 - Memphis 的聯邦快遞總部。聯邦快遞每日有超過 12,000 名員工在機場貨運集

散站工作,其中白天有 4,000 名,深夜同時段最多有高達 8,000 位 員工進行作業,曼菲斯總部每日處理包裹貨物量為 330 萬件包裹, 複雜的集散站處理動線與效率,讓參觀的出席貴賓印象十分深刻。

- 曼菲斯機場的定位,客運方面係做為OD型(起迄型)機場, 貨運方面則作為全美國的輻輳轉運機場,並為聯邦快遞全球營 運總部。根據2007年資料,曼菲斯機場客運量535.7萬人次 /年,起降架次37.5萬;貨運量385萬噸,排名全球第1。




圖:曼菲斯機場平面及設施一覽圖




圖:聯邦快遞於曼菲斯機場之貨站設施鳥瞰照

伍、 展覽部分



本次出國行程藉由返國轉機之機會,順道拜訪達拉斯國際機場 (Dallas Fort Worth International airport, DFW), 洽談雙方締結姐妹機場之意向,達拉斯機場更盛情接待我方參訪該機場之相關設施,包括新落成啟用之 Terminal D,連結五座航廈之 PMS 系統、PMS 機廠辦公室、AOC 機場監控中心與 EOC 緊急應變中心辦公室等。

EOC 辦公室依 EOC 經理席、Finance、Operation、Logistics 等設置分組席位,並設置有全套監控系統,並隨時視天氣、飛航事件召集各席位人員齊聚於此,排練與商討應變對策。




圖:達拉斯機場緊急應變中心 EOC 辦公室

AOC 監控中心辦公室為達拉斯機場監控核心,但非唯一之機場監控辦公室,仍下轄有區域之中控中心,各中控中心隨時將第一線旅客問題或機場問題作即時處理,如遇有需整合機場跨單位資源解決之緊急事件,則立即回報 AOC 監控辦公室進行資源重組與決策,除具分工效率外,AOC 監控中心扮演了達拉斯機場緊急應變的大腦中樞,隨時第一線提供機場全面性的安全問題檢視與處理。



柒、 心得與建議

本次出席世界航空城論壇暨展覽係桃園機場首度站上國際舞台,向國際機場專業人士介紹並說明桃園機場之未來規劃,同時進一步提升我國之國際地位。近年來,亞洲鄰近機場如中國大陸之北京首都機場、上海浦東、虹橋機場、香港赤鱲角機場及新加坡樟宜機場、韓國仁川機場等,不僅已陸續完成新航廈之建設,更積極推動航空城發展策略,試圖以良好且完整之基礎交通建設,以及便利綿密的航網,建立虹吸力量,吸引國際人士及產業湧入各機場,也進一步提升各機場在國際上之知名度,對於各國經濟亦有十分顯著之貢獻。因此,本次參訪歸納出三點心得與建議,說明如下:

一、 航空城概念已近成熟,各國發展重點機場之競爭態勢儼然成形

本次世界航空城論壇暨展覽係為歷年來出席貴賓人數最多,現場並與來自聯邦快遞、達拉斯機場、達美航空、上海機場集團等各國先進交流,體會到國際主流航空市場的發展之蓬勃,競爭之激烈,大部分主流機場莫不積極投入基礎設施的提升、航網之佈局與推出獎勵誘因等政策以吸引國際知名業者或產業進駐,甚而根據本身地理位置與產業發展特色,找到空運發展的利基點,例如荷蘭的史基浦機場因位處歐陸河運及鐵路運輸的輻輳點,更是位處歷史上生產花卉的重點出口國,故將本身定位為複式運輸的交會點,不僅

找到了史基浦機場鮮明的定位,更找到了建設航空城產業聚落的發展條件。因此,桃園國際機場更應積極與國際專業先進交流,知己知彼,接軌全球是本機場責無旁貸的工作。

二、 航空城發展概念類似,應從同中求異,創造利基

鑒於鄰近各國機場發展航空城之概念仍大致朝向以機場為核心,建設良好之聯外交通系統,搭配發展產業專區、商業中心、飯店、購物、會展、住宅等,但此航空城發展模式似採複製模式,並非自機場所在位置之產業特性、都市發展政策、產業發展與全球供鏈的角色扮演等思考機場航空城的定位,因此建議本機場航空城之開發規劃,應搭配思考在地產業特性與全球產業之分工,究竟有哪些產業有進駐機場周邊發展之必要,是否仰賴航空運輸並能創造加值利益等。

三、 桃園機場應充分掌握先天優勢,強化與國際接軌

在本屆世界航空城論壇中,大會主辦單位與大會主席 Prof. John D. Kasarda 曾多次在演講中或研討會中提及本機場的案例,大力讚揚我國過去數年之兩岸開放政策,已大幅提高本機場之客運及貨運量,自 2008 年全球金融危機以來迄今,當全球機場之客貨運量亦正遭受波及而依然委靡不振時,兩岸開放政策已使桃園機場的客、貨運量成長於 2010 年創下歷史新高紀錄(客運量達到 2500

萬人次/年,貨運量達 176 噸/年),甚而名列全球機場客貨成長之前段班。鑒此,桃園機場位居東亞輻輳中心之優異地理位置,固然為近年來躍進式成長的先天優勢,但為求桃園機場之永續發展,更應持續配合在政府的全球化經濟開放政策下,不斷提升自我實力,從基礎建設至服務品質面力求改革與升級,以期能與國際接軌,不僅機場可作為我國與國際主流市場的接口橋樑,更幫助我國能在全球化市場中持續保持領先地位。
