第 7 屆世界回教經濟論壇 (The 7th World Islamic Economic Forum)

一、 出國任務緣起

「世界回教經濟論壇」(The World Islamic Economic Forum, WIEF)於 2006 年 3 月 6 日創設，其成立之目的為增加全世界回教國家及社群之貿易與商業活動，以促進其人民之福祉。WIEF 欲團結回教世界成為一個可獲利的(lucrative)貿易及投資核心集團(caucus)，以吸引來自全球各地之外國投資者及商業合作夥伴。WIEF 認為，「合作」(collaboration)為 21 世紀國際關係中顯著的特色(salient feature)，商業合作夥伴關係的建立將成為回教與非回教國家間和平及繁榮的真誠橋樑(genuine bridges)。WIEF 基金會邀請我方派員擔任第 7 屆「世界回教經濟論壇」本(100)年 6 月 9 日上午第 3 場次，主題為「創新中小企業：引領未來成長」(Innovating SMEs: Drving Future Growth)之講者，就我協助中小企業創新政策進行經驗分享。

二、 要求目標與成果

- (一) 闡明有關我中小企業創新政策，並與與會產官學研代表進行實務經驗分享及交流。
- (二) 加強與回教國家及社群之高層經貿官員及學者專家交流與互動，提高台灣在國際中小企業領域之能見度，並促進雙邊經貿關係。

三、 任務行程及內容

(一) 本年6月6日(星期一)上午7時45分啟程，經南韓首爾及哈薩克阿拉木圖轉機於同日晚間8時55分抵達哈薩克阿斯坦納市；7日至9日參加本論壇；10日晚間8時15分搭機經哈薩克阿拉木圖及南韓首爾轉機返國，6月11日(星期六)中午12時5分抵達台北。

(二) 6月7日：在本次WIEF正式開幕前，主辦單位另舉辦2場分別以企業婦女及青年領袖為主題之論壇，該2論壇開幕式於本日上午9時舉行，首先由哈薩克副總理兼產業暨新科技部部長 Aset O. Issekeshv 致歡迎詞，其後並分別邀請WIEF基金會主席 Tun Musa Hitam 及哈國總理 Karim Massimov 致詞。開幕式結束後，筆者選擇參加「青年領袖論壇」(Young Leaders Forum)，謹將該論壇各場次活動摘要如下：

1. 領導進行式－成功軼事(Leadership in Motion: Anecdotes of Success)：欲創造未來的領導者及擘劃一個國家的未來，成功的故事必須被分享及建立在不同的世代間。邁向成功的道路上充滿各式各樣的挑戰，需要以強大的決心、創造力及洞察力將挑戰轉化為機會。過去成功的故事是無價的軼事，可幫助下世代的領導者形塑其建設性的未來。
2. 文明化的繁榮－發揮社會企業家精神(Humanising Prosperity: Making Social Entrepreneurship Work)：社會企業家精神為永續企業協助改善社會福祉之一種理念，當政府及企業部門無法處理社會問題時，這責任就仰賴擁有社會理念及創業精神的男女青年。一個有益的

社會企業家精神生態系統(ecosystem)，必須包括政府、企業部門及民間社會等主要參與方。

3. 透過藝術創造改變—圖像、寓言、詩歌(Creating Changes Through Arts: Images, Fables and Poetry)：當主流媒體無法傳達一個人的困境，那就是由藝術來訴說一個故事的時候。創造性的藝術，其教育及改變意見與世界觀的能力是不可忽視的力量。隨著主流媒體充斥著大量誤解，藝術扮演糾正錯誤的角色在現今世界顯得更加重要。
4. 培育全球性在地化的冠軍—建構健全的生態系統(Nurturing Glocal Champions: Building the Right Ecosystem)：中小企業在型塑國內經濟扮演舉足輕重的角色。在若干國家中，中小企業為其勞動力的主要雇主，不僅促進其國內財富的流通，並對其經濟發展貢獻卓著；但如何建構一個有利於中小企業發展的生態系統，以及政府在發展中小企業過程中如何扮演關鍵角色等議題均有待進一步研討。

(三) 6月8日：本日上午10時舉行本屆WIEF開幕式，首先由WIEF基金會主席 Tun Musa Hitam 致詞，嗣由哈薩克總統 Nursultan Nazarbayev 發表專題演說並正式揭開本次論壇序幕，隨後另邀請馬來西亞總理 Dato' Sri Najib Tun Abdul Razak、吉布提(Djibouti)總統 Ismail Omar Guelleh、巴林(Bahrain)總理 Khalifa bin Salman Al Khalifa、塔吉克(Tajikistan)總理 Oqil Oqilov，以及印尼副總統 Boediono 等貴賓致詞。開幕式結束後，筆者續參加2場全體會議，謹將該等會議摘要如下：

1. 企業家精神為成長之工具—邁向成功之路經圖

(Entrepreneurship as a Vehicle of Growth: A Roadmap to Success)：企業家精神是一種心態或文化，為社會中的利益相關者(stakeholders)及機構(institutions)等因素結合結果之體現。所謂「機構」包括教育系統、民間社會、勞工及商業部門等，其對建立一個健全的生態系統以促進企業家精神的興盛，扮演非常重要的角色。因此，政府擬定增進該等機構能力之政策，以培育其人民的創業家精神之文化至關重要。一個健全的生態系統能夠協助具創新思維的世代公民，創造可提升全民社經福祉的產品及服務。

2. 新興市場之回教銀行及金融業—抓住機會，克服挑戰 (Islamic Banking and Finance in Emerging Markets: Seizing Opportunities, Overcoming Challenges)：回教銀行及金融業為現今世上成長最快速的產業之一。事實上，絕大部分倖免於金融危機衝擊的回教金融服務業，未來將有更大的成長空間，並將鼓勵回教銀行業者尋求在新興市場拓展業務之可能機會，以使其投資獲取最大報酬。

(四) 6月9日：本日上午筆者受邀擔任第3場次分組座談，主題為「創新中小企業：引領未來成長」(Innovating SMEs: Driving Future Growth)之講者。筆者以「台灣中小企業政策及促進中小企業創新成長之策略」(Taiwan SME Policies and Strategies to Promote SMEs' Innovative Growth)為題進行經驗分享。首先說明促進中小企業創新之重要性，續扼要介紹我國協助中小企業創新之相關輔導措施，如創業領航計畫、產學合作、中小企業創新服務憑證、整合產業群聚創新輔導，以及資通訊與電子商務之應用等。最後總結如

下：

1. 政府必須有長期的遠見，並推動可行的行動計畫以符合中小企業之需求。
2. 中小企業成功的關鍵因素：創新、速度、價值及企業家精神。
3. 創新政策必須提供新創企業獲取財務融通、研發、行銷及產品商業化等支援的管道，並促進技術及人力資源的升級。
4. 台灣可作為在創業、創新、育成、能力建構，以及輔導中小企業新政策與工具等方面最佳範例的學習對象。

四、 感想與建議

- (一) 本屆論壇計約有 2,500 名產官學研代表與會，盛況空前。此外，該論壇首次邀請我方參加，亞洲國家部分，會中僅見中國及日本各一名代表與會，顯見我輔導中小企業之政策及措施深獲主辦單位之肯定及重視。在筆者簡報之分組座談會上，與會者亦對我輔導中小企業創新成長之策略及作法表示極大之興趣，並引發廣泛之共鳴，紛紛探詢並盼深入瞭解我方具體之作法以作為借鏡。
- (二) 哈國面積達 271 萬平方公里，東西橫貫 3,000 公里，南北縱深 1,600 公里，為全球第 9 大面積國，足足為台灣的 75 倍大。台灣與哈國雙邊貿易起步較晚，台哈雙邊迄未互設官方機構，且尚未有官方常態性對話管道，至今亦未見任何一家台灣廠商正式赴哈國投

資，僅見一家廠商在阿拉木圖從事成衣貿易。此外，在貿易上最大之困難點在於台灣出貨到哈國的路線太遠致成本增加，利潤被高昂的運費所消耗殆盡，以致嚴重影響價格競爭力。由於台灣對中亞市場相當陌生，台哈雙邊貿易金額仍然低迷，以 2008 年最高峰為例，僅突破 1 億美元。我外貿協會於 2004 年 7 月在阿拉木圖設立辦事處以來，台哈貿易總額已成長 3 倍餘，顯示台哈貿易具有發展潛力。目前台灣外銷哈國以 ICT 及產業機械為大宗，而台灣自哈國進口之貨品幾乎 90% 以原物料為主，兩國貿易上的互補性甚高，為擴大台哈經貿合作之契機。

- (三) 哈國原物料豐富，國內工業多以原物料開採及加工業為基礎。農牧業、食品及飲料可勉強自給自足；惟製造業技術層次低且缺乏產業聚落支援，其對全國經濟貢獻度不大。此外，哈國人口少，進口商品屬於小眾市場，進口訂單量小而多樣，且其鄉村人口占全國人口 40%，不利我商行銷運籌。由於哈國經商環境特殊，雖然脫離蘇聯獨立後已近 20 年，但主要商業溝通語言幾乎仍以俄語為主，且簽證取得曠日費時又所費不貲，故對我商而言，行銷成本較為高昂。
- (四) 俄國本即哈薩克之宗主國，哈國對俄國的歷史及文化存有強烈的認同感，兩國不僅在政治、軍事及外交上口徑一致，在經濟與貿易上更是合作無間。哈國基礎建設、產業投資、消費商品、零組件及生產機器等，均是直接或間接自俄國進口，故俄國對哈國的經貿具有舉足輕重的影響力，目前俄國仍為哈國最大也是最重要的貿易夥伴。另外，由於哈國石油、天然氣及礦產資源豐富，最近幾年來，美國、中國、^{大韓}韓國、日本

及土耳其等國積極用心經營及佈局哈國市場，此一趨勢值得我方深思及重視。

- (五) 筆者於6月10日在我外貿協會駐哈國阿拉木圖台灣貿易中心廖主任隆銘的陪同下，拜會阿斯坦納商工會副會長 Elena Mikhailovna，就哈國經貿情勢、台哈雙邊經貿關係及外人投資情形等交換意見。M副會長盼我商組團赴哈國考察及投資，以增進雙邊經貿關係。其後，在廖主任的安排下，拜會哈商 Kahan 公司阿札特總經理，瞭解該公司在哈國經營狀況，並就哈國經濟及投資環境交換意見。阿札特總經理對我國產品表達高度興趣，將應外貿協會邀請來台參觀「台北國際專業展」，顯見哈國廠商對採購我國產品有相當意願，值得我商進一步拓銷該國市場。

Taxi

Taxis on call are reliable and safe, but they'll charge a minimum of 1,500 tenge. In Astana, please call 22 22 22 or 39 79 79 (no English spoken). You can also flag down gypsy taxis/ private cars in the street starting from 300 tenge to go anywhere in the city. However, take care, especially at night, and do not get into a car with more than one person already in it. In Astana, taxis tend to be a bit more expensive, so be prepared to pay up to 500 tenge.

Public Transport

In Astana, the only form of public transport is the bus, which runs from 6am to 8pm. The fare is 40 tenge. The number and the main stops of the route are written on the side of the bus and announced by the instructor. In the absence of information about destinations at public transport stops, and because the information on public transport is in Cyrillic, it may be easier to take taxis in town.

FOOD

Based on nomadic roots, horse meat and mutton (meat from sheep) are the basis of a majority of Kazakh dishes. Dishes include shuzhuk (a type of sausage made from smoked horse meat), and kuyrdak.

Daily meals for Kazakhs usually are very hearty, always including bread and usually another starch such as noodles or potatoes and then a meat. One common dish is pilaf, which is often associated with the Uzbeks. It is a rice dish usually made with carrots, mutton, and a lot of oil. Soups, including Russian borscht, also are very common. Soups in Kazakhstan can be made of almost anything. Borscht is usually red (beet-based) or brown (meat-based), with cabbage, meat, sometimes potatoes, and usually a large dollop of sour cream. Pelimnin, a Russian dish that is made by filling small dough pockets with meat and onions, is very popular with all nationalities in Kazakhstan and is served quite often as a daily meal.
