





Building on a similar survey from 2007, this briefing will present initial findings from the recently completed survey of research park directors, who provided data on park characteristics, trends in university to gauge the economic impact of university research parks. Additionally, the Battelle study will feature Case Studies from university research parks around the world. Included in the Case Studies will be the Kyoto Research Park in Kyoto, Japan. Dr. Koji Okuda will present the Kyoto Case Study, including examples of lessons learned at the Kyoto Park since its inception more than 20 years ago.

8:30 am Changing Models for Financing Higher Education in the U.S.

Dr. David Ward, Chancellor, University of Wisconsin-Madison

Public universities in the U.S. are reaching the limits of old assumptions, facing global competition and the challenges of building a knowledge economy while navigating new ratios of public/private support. UW-Madison is working to retain its position as one of the world's top research institutions, generating \$12.4 billion of economic impact each year for the state of Wisconsin. Technology transfer — and the research parks where that technology is created — are critical to efforts to maintain excellence. Still, like other public universities, there is an ongoing resource crisis that threatens our core mission and principles. The pendulum isn't expected to swing back to the old model, so it is up to university leaders to develop a new one. Universities need to look seriously at their operations to find solutions within, become more nimble and creative, and think about philanthropy in a new way.

In this election year there are a lot of uncertainties. 



The U.S. national labs must redouble their effectiveness in meeting the nation's pressing scientific needs through increased technology transfer and collaboration. Local governments, businesses, academic institutions, and economic development agencies are looking to attract the best and brightest. In the East Bay Area of San Francisco, the city of Livermore, and two national laboratories are working together to create a 4th node of innovation in the backyard of the already well-establish technology centers of Silicon Valley.
