With strong background in economics and econometric techniques, he has (and led) various research papers and publications on trade and macroeconomic policies and Vietnam's integration process. He is also progressing in other working papers on: Vietnam's aspirations of economic development till 2030; effectiveness of Vietnam's monetary policy in relation with financial regulations and financial market structure; and possibility of applying inflation targeting regime in Vietnam.

Mr. Nguyen is currently Vietnam's representative to the Economic Committee, Asia-Pacific Economic Cooperation (APEC) forum, where he acts as the coordinator of the Friends-of-the-Chair (FotC) group on Corporate Law and Governance. He also leads Vietnam's structural reform under APEC framework. In line with Vietnam's individual plan to implement APEC New Strategy for Structural Reforms, Mr. Nguyen is currently overseeing APEC-supported project on "Enhancing Capacity for Public Investment Project Appraisals in Vietnam".

### 2013 ANSSR Mid-Term Progress Report and Development of a Reporting Mechanism

In Honolulu, APEC Leaders committed to implement individual APEC New Strategy for Structural Reform (ANSSR) plans by 2015 in order to reduce behind-the-border barriers and promote balanced, inclusive, and sustainable growth.

Ministers called on all relevant APEC fora to contribute to capacity-building activities based on the specific reform priorities each member economy plans to implement under the ANSSR through 2015. Moreover they instructed officials to actively promote, monitor, and review implementation of ANSSR.

To fulfill Leaders' instructions, including the monitoring of individual ANSSR plans' implementation and determining what capacity-building activities will be most productive to undertake, Australia, Russia and the United States propose that APEC officials continue active dialogues among APEC economies concerning best practices and effective implementation of individual ANSSR plans.

On this basis we propose a mid-term progress report of individual economies ANSSR plans in 2013 which would be available publically. This proposed mid-term progress report would allow economies to highlight accomplishments in implementing structural reform priorities and will enable economies to track progress towards achieving their stated objectives of implementing structural reform by the end of the ANSSR process in 2015. The 2013 mid-term progress report will also assist economies to identify where more efforts are needed.

To support economies ahead of a mid-term progress report, a reporting template was developed. The information, which is going to be collected by means of this template, will develop a basic framework for mid-term progress report. The collected information will be used to develop new capacity building efforts that address the key challenges identified by APEC economies.







附件六: Competition Policy and Law Group (CPLG) Terms of Reference



### Competition Policy and Law Group (CPLG) Terms of Reference (ToR)

### Article 1 Establishment of the APEC Competition Policy and Law Group

 The APEC Competition Policy and Law Group (the "CPLG") is established as the group under the APEC Economic Committee (the "Committee"). The CPLG shall report on its activities and submit its work plan to the Committee.

#### Article 2 Objectives

The Objectives of the CPLG are to:

- 1. Promote the understanding of regional competition laws and policies.
- 2. Identify areas for technical cooperation and capacity building among APEC member economies.

### Article 3 Scope of Activity

- 1. Scope of Operations of the CPLG is to serve as a forum for competition authorities and experts:
  - (i) To exchange information on competition laws and policies,
  - (ii) To develop and enhance understanding of the competition laws and policies of APEC economies:
  - (iii) To share experiences and expertise on activities relevant to the implementation of competition laws and policy;
  - (iv) To examine, when possible, the impact of competition laws and policy on trade and investment flows;
  - (v) To identify areas for capacity building and technical cooperation on the implementation of competition laws and policy;
  - (vi) To periodically review the group's Collective Action Plans; and
  - (vii) To do outreach and public relations to APEC Stakeholders on the achievements of the group as and when appropriate.
- 2. In collaborating with other relevant APEC fora and the business sector, the CPLG will serve as a forum
  - (i) To coordinate and discuss as appropriate the implementation of cooperative initiatives such as but not limited to Structural Reform with other relevant APEC fora, such as the Economic Committee and relevant international organizations.
  - (ii) To report progress and outcomes of each cooperative initiative to the ECCommittee, and when necessary make recommendations thereto; and
  - (iii) To invite when appropriate other relevant APEC fora, the APEC Business Advisory Council (ABAC)—and/or other relevant experts to participate in/or observe the group's activities.

### Article 4 Procedures

1. The CPLG disseminates the results of its work within APEC and beyond as appropriate.

- 2. In conducting its activities, the CPLG may draw as appropriate on the work of other regional organizations and multilateral institutions and on private sector.
- All members of the CPLG endeavor to distribute documents for discussion by the CPLG no later than 2 weeks prior to the meeting at which the document is intended to be discussed.

### Article 5 Structure of the CPLG

- 1. The CPLG comprises officials of competition law enforcement agencies of all member economies.
- 2. The CPLG shall have a Convenor and also, as appropriate, may have a Vice-Convenor.
- 3. The CPLG shall normally meet once a year.

### Article 6 Selection and Term of the Convenor and Vice-Convenor of the CPLG

- 1. The CPLG members shall elect a Convenor and a Vice-Convenor among the member agencies of the CPLG.
- 2. The Convenor and the Vice-Convenor shall each serve a renewable term of two years.
- 3. If the Convenor chooses to leave the CPLG before the end of the two-year term, the Vice-Convenor shall act as the Convenor for the remainder of the two-year term. When the CPLG has no Vice-Convenor, the outgoing Convenor's Office shall send another representative to serve as Convenor for the remainder of the two-year term.
- 4. The incumbent Convenor will initiate the voluntary nomination process for a new Convenor at least three months before the end of the term. Shortly after all nominations are received, the Secretariat will send them out to CPLG members for review. The incumbent Convenor will circulate the outcome of the election. If there is no nomination, the incumbent Convenor shall call for further nominations. Should no member economy volunteer nominating, the next APEC host economy will be recommended to act as Convenor of the CPLG.

#### Article 7 Responsibility of the Convenor of the CPLG

The Convenor is responsible for:

- 1. Chairing an annual CPLG meeting.
- 2. Attending meetings of the Committees to make reports on the CPLG activities.
