Environmental Justice

從 2007 年 6 月 1 日起，三藩市的餐飲業者和餐館必須使用可堆肥或可回收的外賣餐具。在三藩市製作的食物不得再使用聚苯乙烯泡沫 (Styrofoam™) 一次性餐具。



商業和居民可以選擇多種可堆肥或可回收的替代餐具，減少垃圾量，降低服務費用。三藩市數千家餐館和其他商業正在參與食物殘渣和可堆肥物收集計劃，並獲得多達 75% 的垃圾費折扣。居民也可以使用堆肥和回收服務，把可堆肥或可回收餐具放入綠色或藍色的垃圾箱中。

三藩市環境局 (SFEnvironment) 可以幫助商業選擇合適的餐具，並提供現場指導以及協助食物殘渣和可堆肥物收集。

新餐具法令須知事項

新餐具法令的要求是什麼？

- 在三藩市境內製作和供應的食物不得使用聚苯乙烯泡沫 (Styrofoam™) 一次性餐具，概無例外。
- 在三藩市境內製作和供應的食物可以使用的一次性餐具必須是可堆肥或可回收的，除非沒有比不可堆肥或不可回收替代產品貴 15% 以下的合適產品。(無論價格如何，都不得使用聚苯乙烯泡沫。)

誰必須遵守新的餐具法令？

所有在三藩市境內製作出售和供應食物的餐飲業者都必須使用可堆肥或可回收的餐具。餐館、熟食店、快餐店、展會飲食攤點、流動餐飲車以及所有的市政府設施都必須遵守這項法令。

違反法令的懲罰是什麼？

違反法令可能導致罰款：第一次 = 警告，第二次 = \$100，第三次 = \$200，第四次或之後違反 = \$500。該法令由市府行政官執行，部份執行以投訴為依據，即你的顧客可以向市政府檢舉你的違規行為，電話號碼是 (415) 554-4851。

聚苯乙烯泡沫有什麼不妥？

聚苯乙烯泡沫由原油製成，不可再生，不可生物化解，也不可回收。聚苯乙烯泡沫餐具最終出現在垃圾堆填區、水道或海洋中。它會破裂為碎片，被海洋哺乳動物、鳥類和魚類誤食。醫學研究表明，聚苯乙烯泡沫中的化學成份會致癌，並可能會滲濾到食物或飲料中。

哪些是被批准的餐具？

可堆肥的產品包括：

- 紙或其他植物纖維，例如甘蔗、大米或竹纖維。目前可接受聚乙烯塗層紙，但不允許任何泡沫塗層。
- 標記為「可堆肥」、符合堆肥標準 (ASTM D6400) 的玉米、大豆、馬鈴薯或其他植物澱粉的生物塑膠，例如 PLA 透明塑膠。這些產品應該攜帶綠色條帶或貼紙標記，方便可堆肥物收集和處理人員的識別。

這些產品的描述見於 SFEnvironment.org/foodservice 或致電 (415) 355-3700 索取產品清單。

可回收的產品包括：

- 鋁箔紙或鋁箔盤以及  號、 號和  號塑膠製造的容器和封蓋。

哪裡可以買到替代餐具？

向你目前的供應商詢問哪些產品可以符合市政府的新規定。可堆肥和可回收產品的供應商可以在網頁 SFEnvironment.org/foodservice 找到，你也可以致電 (415) 355-3700 索取供應商名單。

減少餐具垃圾，你可以做什麼？

- 允許和鼓勵顧客在購買外賣食物時使用自己的杯子或可重複使用的外賣容器，並向自帶餐具的顧客提供折扣。
- 向顧客收取費用，以收回一次性外賣容器的額外成本。
- 向堂食顧客提供可重複使用的餐具，而不是一次性餐具。

Requirements of San Francisco's Food Service Ware Ordinance

Effective June 1, 2007, food vendors and restaurants in San Francisco must use compostable or recyclable to-go containers. Polystyrene foam (Styrofoam™) disposable food service ware can no longer be used for food prepared in San Francisco.



There are many food service ware alternatives that can be composted or recycled by businesses or residents that can help reduce their trash volumes and service costs. Thousands of San Francisco restaurants and other businesses are recycling and participating in the food scrap and compostables collection program and as a result are getting discounts of up to 75% off their garbage service costs. Residents also have access to composting

and recycling collection services and can put compostable or recyclable food service ware in their green or blue carts.

San Francisco Department of the Environment (SF Environment) is available to assist businesses with finding suitable food service ware and can provide free on-site training and assistance to participate in the recycling and food scrap and compostables collection programs.

What You Need To Know About The Food Service Ware Law

What are the requirements of the new food service ware law?

- San Francisco food vendors are prohibited from using polystyrene foam (otherwise known as Styrofoam™) food service ware for food prepared and served in San Francisco, with no exceptions.
- All other disposable food service ware for food prepared and served in San Francisco must be compostable or recyclable unless there is no suitable product that is within 15% of the cost of non-compostable or non-recyclable alternatives. (There is no cost exemption for Styrofoam™).

Who has to follow the new food service ware law?

All San Francisco food vendors selling food prepared and served in San Francisco must use compostable or recyclable food service ware. Restaurants, delis, fast food establishments, vendors at fairs, food trucks, and all City facilities and contractors must follow this law.

What are the penalties for non-compliance?

Violations may result in fines: 1st time = warning, 2nd time = \$100, 3rd time = \$200, 4th or more time = \$500. Enforcement is by the City administrator and will be in part complaint-driven, meaning your customers may notify the City of violations, by calling **City Customer Service 3-1-1**.

What is wrong with polystyrene foam (Styrofoam™)?

Made from oil, polystyrene foam is non-renewable, non-biodegradable, and non-recyclable. Polystyrene foam food service ware ends up in landfills, waterways or the ocean. It can break into pieces, which are often mistaken for food and ingested by marine animals, birds, and fish. Medical studies suggest that chemicals in polystyrene foam can cause cancer and can leach into food or drinks.

What products are acceptable?

Compostable products include:

- Paper or other plant fiber, such as from sugarcane. Polyethylene film coating on paper is currently accepted, but not any foam coating.
- Corn or other plant-based bio-plastics such as "PLA" must be labeled "compostable", meet compostability standards (ASTM D6400), and have a green band or green sticker to allow easy identification by the compostables collector, processor, and the public.

Recyclable products include:

- Aluminum foil or trays and plastic containers and lids.

Not acceptable:

- Plastic wrap, Styrofoam™ or foam products.

What can you do to reduce food service ware waste?

Ask your current supplier about products that meet the City's new requirements. Suppliers for compostable and recyclable products can be found at **SFEnvironment.org/foodservice** or call **(415) 355-3700** to request list of suppliers.

What can you do to reduce food service ware waste?

- Allow and encourage customers to bring their own mugs or reusable to-go containers for take-out by offering a discount.
- Charge customers a fee to cover any additional costs for disposable take-out containers.
- Use reusable service ware instead of disposable ones for eat-in customers.



San Francisco Mandatory Recycling and Composting Ordinance

Everyone in San Francisco is required to separate and put their recycling, composting, and trash in the right place.

The City and your recycling company offer a variety of free services and assistance including kitchen compost pails, consultations, container labels, signs, commercial building toolkits, educational materials, multi-lingual trainings, and more.

Businesses

Property owners/managers, including of apartments, condos, TICs, food establishments, and events are required to provide color-coded, labeled containers in convenient locations: blue for recycling, green for composting, and black for trash. You must also educate tenants, employees, contractors, and janitors on what goes in each container. Food vendors that provide disposable food service ware or to-go containers must have blue, green, and black containers for use by customers and visitors, placed inside near a main exit.

Residential Property Owners

Blue recycling and green composting carts are free with your trash service. You may be able to lower your trash bill by recycling and composting more, and ordering a smaller black trash cart.

Recology provides apartment starter kits and pails for tenants to collect kitchen food scraps. Food scraps can also be placed in paper milk cartons, paper bags, or wrapped in paper before being placed in the green cart.

Renters

Ask your manager to sign up for composting, recycling, and trash service.

Renters can report unresponsive managers by using the anonymous form at SFEnvironment.org/mandatory

Enforcement

Residents and businesses are required to subscribe for adequate trash, recycling and composting service. We strive mainly to educate and assist. Fines may be given only in cases of blatant on-going non-compliance.

Recycling Theft

It is illegal for a third party to mix or take materials out of the recycling container provided by your collector. Please report recycling theft at RecologySF.com or by calling (415) 330-1300.

You're going to toss it somewhere, right?

It's as easy to put it in the recycling cart as it is in the garbage.
But which cart you use makes a world of difference.



Setup is so simple, even for food scraps.

Use a separate container in your home for regular recycling—like paper, bottles, and cans. For food scraps, just toss them into a compostable container, like a milk carton, or a kitchen pail with a compostable liner—newspaper, paper bag, or compostable bags—and then empty it all into the green cart. (Did you know the city's food scraps are made into soil for Bay Area farms?) Don't use conventional plastic bags, though, because they are not compostable.

Think of recycling as "donating" to a good cause every week.

在家裡面用一個分開的容器來裝可回收物品——例如紙張、瓶和罐。殘餘食物可以置入可分解的容器內，例如裝牛奶的紙盒，或用報紙、紙袋、或可堆肥袋內襯的廚房小提桶，然後放入綠色的堆肥桶內。（你知道嗎？市內收集的食物殘餘，可變成灣區農場用的泥土？）請不要用一般的膠袋，因為膠袋是無法自然分解的。

將回收視為每個星期「樂捐」的有意義目標。

Lo va a botar en alguna parte, ¿no es cierto?

Es tan fácil ponerlo en el recipiente para reciclaje como en la basura. Pero el recipiente que se usa hace una diferencia enorme.

La preparación es muy sencilla, hasta para los restos de comida.

Use un recipiente distinto en su casa para el reciclaje normal, tal como papel, botellas y latas. Para los restos de comida, simplemente échelos en un envase biodegradable—como un cartón de leche o un balde de cocina con un forro biodegradable—periódico, bolsa de papel o bolsas biodegradables, y después vacíelos en el recipiente verde. (¿Sabía usted que los restos de comida de la ciudad se convierten en tierra para las granjas del Área de la Bahía?) No use bolsas de plástico convencionales porque éstas no son biodegradables.

Piense en el reciclaje como una "donación" a una buena causa todas las semanas.

Four Course Compost

Application Guide:

New Fruit Trees, Vineyards, Roses & Shrubs

Dig hole 2 to 3 times bigger than the root ball of the trees, and mix Four Course Compost up to 50% with soil. Work some of this mixture into the bottom of the hole and fill the hole half full with water. Then put root ball into it and backfill around the roots. Tap lightly without compacting before soaking with more water.

Vegetable, Flower Gardens & New Lawns

Incorporate 1/2 to 3 inches of Four Course Compost into the top 6 inches of soil; sow the seeds of your choice and soak with water immediately.

Potting & Window Boxes

Thoroughly mix up to 30% of Four Course Compost with the material you may have such as soil, sawdust, neutralized peat, etc.. to form the basic mixture to fill boxes or pots.

Established Fruit Trees, Roses & Shrubs

In the fall to early spring of each year, right before the rain comes, evenly spread 1-2 inches of Four Course Compost along the trees near the roots. Till in if possible. Apply one more time before flower blooming for better yield.

Established Lawns

Evenly spread 1/4 to 1/2 inch of Four Course Compost across the top of the lawn and work in with back of a yard rake. Water immediately.
