#### Progress report 2014

#### I. Institutional development and planning

#### **Background**

For the transitional period, APFNet has been operating with the following governance structure:

- · Interim Steering Committee
- · Focal Points as a working mechanism
- Project Appraisal Panel
- Executive Director
- Secretariat

As of 2010, APFNet Focal Points have operated effectively as a working mechanism which played an important role in facilitating communication and in implementing APFNet activities. They have been meeting once a year to review annual progress reports and make recommendations on the proposed annual work plan. This mechanism also serves as a platform to enhance coordination and cooperation between APFNet and its members.

The Interim Steering Committee was established in 2011 as an advisory body on major issues related to APFNet's development such as its Strategic Plan, policies and procedures, Operational Framework and annual work plan. It consists of 11 members: Australia, China, Malaysia, Indonesia, Papua New Guinea, Thailand, the United States of America, Viet Nam, the Food and Agriculture Organization of the United Nations, the International Tropical Timber Organization and the Nature Conservancy.

In line with the long-term arrangement envisaged in APFNet's Strategic Plan (2011-2015) and Operational Framework, the governance structure of APFNet will be formalised with the establishment of a Board of Directors and a Council. The Board will serve as a decision-making body and the Council will assume the function and advisory responsibilities of the Interim Steering Committee and Focal Points. Efforts in 2014 focused on setting up the Board and Council.

APFNet also started a review of its first Strategic Plan as it prepares to draft the next one to cover the period 2016-2020.

#### Work progress 2014

- 1. Sixteen candidates were nominated in response to a call for nominations for the first Board of Directors by the January, 2014 deadline.
- 2. Co-organization of the Fourth Meeting of the APFNet Interim Steering Committee and the Fifth Annual Meeting of the APFNet Focal Points, *Chiang Mai, Thailand, 6-8 May*, in collaboration with the Royal Forest Department of

#### Thailand.

- The Fourth Meeting of the APFNet Interim Steering Committee approved the Draft Plan of Establishing the Selecting Committee for the Initial Board and developed the document into the Terms of Reference of the Selection Committee; the Selection Committee was then established and met after the meeting of the Interim Steering Committee to select Board members among the candidates; 12 Board members with staggered terms were selected and recommended by the Selection Committee to the host economy.
- The Fifth Annual Meeting of the APFNet Focal Points approved the Draft Plan of Establishing the Council of APFNet (finalised in August) and also revised the Work Plan of 2014.

#### 3. Appointment of the Directors

The Selection Committee, via the Secretariat, forwarded the recommendation letter and other required documents to China, the host economy, who processed and issued the appointment letters to the prospective Board members.

- 4. Preparation of documents for the first meeting of the Board Preparation of a series of documents for the Board's review at the first meeting began:
  - Election of the Chair of the Initial Board of Directors;
  - · Rules of Procedure of the Board of Directors of APFNet;
  - · Framework of Staff Regulations and Financial Regulations;
  - Strategic Plan 2016-2020 draft framework;
  - · APFNet governance structure;
  - Progress report 2014 and annual work plan 2015
- 5. Launch the establishment of the APFNet Council, Dec, 2014

According to the Plan of Establishing the Council, which was reviewed and finalized in August, APFNet member economies and organizations were sent a request to appoint their Council representative as a first step toward the formal establishment, and first meeting of the Council.

6. Preparation of APFNet Strategic Plan 2016-2020

In July, APFNet launched the process of preparing its second Strategic Plan, 2016-2020, with first task being a review of the current Strategic Plan, followed by beginning work on the draft of the strategic plan.

#### II. Partnerships

Partnerships are indispensable tools and bridges for APFNet to add value to and leverage resources available for joint program activities, and enable APFNet to

expand its engagement in regional and international forest processes and programs.

#### Work progress 2014

1. Co-organization of the Regional Workshop on Forest Products Statistics, *Kunming, China, 17-19 Sep* 

As a follow-on to the Workshop on Forest Products Statistics in China in 2013 and to further promote the partnership with ITTO, APFNet co-organized this event in collaboration with ITTO and FAO in Kunming, China. Attended by 12 officials from the forest department and Customs department of the six economies in the Greater-Mekong Subregion, the workshop sought to learn existing challenges, strengthen data collection on forest products production, improve data collection systems and reduce discrepancies between trade statistics reported by participating economies.

The ED of APFNet met with Mr Emmanuel Ze Meka, Executive Director of ITTO shortly after the opening session, and briefly discussed future cooperation, including setting-up a joint booth at the UNFCCC COP 20 conference.

2. Joint booth at the United Nations Climate Change Conference, *Lima, Peru, 1-12 Dec* 

Following up the meeting with the ED of ITTO, APFNet set up a joint booth with

ITTO and its local partner AIDER (Association for Integrated Research and Development) in the Voices for Climate exhibition during the COP20 of UNFCCC. This was an opportunity to showcase APFNet's efforts at addressing climate change and to increase its publicity at this international event.

#### 3. MoU with FAO

Building on existing collaboration and recognizing potential synergies in partnering, both sides agreed a MoU could facilitate cooperation in areas of common interest. Collaboration areas include technical cooperation in five thematic areas, and implementation tools include capacity building, information distribution and joint activities. The MoU has been negotiated and is moving through signing procedures.

#### 4. Partnership with CIFOR

Recognising CIFOR's strength in forestry research, APFNet met with experts from CIFOR to discuss future cooperation. Both sides agreed to explore joint activities and possible collaboration in related areas in 2015.

#### III. Policy dialogues

APFNet has regularly worked with international / regional organizations to bring together policy makers and practitioners to discuss common issues and identify solutions.

#### Work progress 2014

1. Forestry cooperation in Greater Central Asia Economies *Beijing, China, 24-26 September* 

An APFNet Regional Workshop on Strategic Forestry Cooperation in Central Asia and Mongolia exchanged information and experiences on forest management, vegetation restoration, trans-boundary biodiversity conservation and sand-binding plants utilization. The workshop also explored the potential regional cooperation opportunities in forestry sector.

2. The Workshop on Mainstreaming Degraded Forest Restoration into Forestry Strategic Plans, *Phnom Penh, Cambodia, 17-19 December* 

The Workshop is one of the activities proposed by APFNet in 2013 under the Platform for Regional Dialogue on Forestry Strategic Planning. During the meeting, participants exchanged experiences and efforts on restoration of degraded forest and forestry strategic plans at both individual economy and in international initiatives. Recognizing the importance and challenges of restoring degraded forests, participants resolved to strengthen collaboration through the Platform for Regional Dialogue on Forestry Strategic Planning.

#### IV. Projects and programs

#### **Background**

As globalization and regional integration accelerates, a regional perspective, instead of country-level analysis and implementation, is increasingly valuable as an approach to sustainable forest management. APFNet works with foresters through developing and financing projects to improve management of forest resources in the Asia-Pacific region, in order to make advances in balancing and addressing conflicts between economic development and environmental protection.

APFNet pilot projects identify and promote best practices of ecosystem-based approaches and forest landscape restoration. By the end of 2014, APFNet, working collaboratively with research/education institutes, government agencies and regional/international organizations, has granted about 12 million US dollars to 20 projects (see the Annex) in Asia and the Pacific. Nine of the projects are regional in scope, covering issues of forest resource monitoring, trans-boundary ecological security, forestry education, forestry policy analysis, forest restoration, and capacity building on forest management.

#### Project impacts

- Drew high level attention to forest issues and forestry in the region;
- Enhanced partnerships and networks for wider dispersal of knowledge and capacity building activities;
- Demonstrated good forest management practices and identified promising models for livelihood improvement.




Figure 1 Number of Projects funded 2010-2014




Figure 2 Funding amount of projects 2010-2014

#### Work Progress in 2014

#### 1. Application and approval in 2014

In the year 2014, three new demonstration projects were officially approved. The fields cover forest-based small business development, watershed management at the landscape level, and forest policy enforcement.

From February to April, 2014, APFNet opened its annual Call for 2015 Project Proposals. Twenty-five project concept notes were submitted from a wide range of economies, institutes and organizations within the Asia-Pacific region. After appraisal, six projects were selected for 2015 APFNet funding.

#### 2. Strengthening of project coordination and supervision

In an effort to further improve the quality of APFNet-funded projects and enhance timely implementation, the APFNet Secretariat has increased its involvement in project development and its supervision of implementation. An APFNet Manual for Project Identification, Implementation and Management (PIIM) and standardized reporting/disbursement procedures have been utilized among project partners to raise efficiency of communication and project implementation. Additional international and local experts were invited to assist with project

design and execution. Monitoring and evaluation has been strengthened, to ensure that projects adapt effectively to changing situations and that programs remain focused on achieving expected outcomes.

#### 3. Project updates

In 2014, 14 projects were in their life cycles. Of those 14, two had finished and been closed, while an additional five had been completed and were in the process of final close out. Of the remaining projects, one had been extended with additional activities, one had resumed implementation following temporary suspension, and five recent projects were in the implementation, or agreement negotiation phase.

#### - Adaptation of Asia-Pacific Forests to Climate Change

The three-year project aims to generate new knowledge and technology to increase the resilience of forests and forest-dependent communities in the Asia-Pacific, particularly in relation to tackling changing climate, deforestation and forest degradation for a vast array of ecosystems. In 2014, the project developed the Climate Change Models, which aim to provide reference on developing adaptive strategies that will facilitate an increase in the resilience of forests and forest-dependent communities in the Asia-Pacific region to climate change.

## - Forest Cover and Carbon Mapping in the Greater Mekong Subregion and Malaysia

The project, initiated in 2011, supports relevant institutes/agencies to estimate forest coverage and above-ground carbon stock in the Greater Mekong Subregion (GMS) and Malaysia to contribute to biodiversity conservation within the region and globally and to APFNet's monitoring of progress towards the APEC 2020 forest cover (and associated carbon stocks) objectives. The key outcomes of 2014 are the Carbon Map Databases, which is expected to help steer the direction of future efforts to improve the synergy between sustainable forest management (SFM) and relevant environmental visions. The tool also demonstrated the potential to be more productive in the longer term.

#### - Sustainable forest management project in northern Lao PRR

This project, designed to translate the Asia and Europe (ASEM) forestry proposal into reality, was launched in April. Key to its initial success was close coordination on design and initial implementation among APFNet, the Lao Ministry of Agriculture and Forestry, and other stakeholders.

To guarantee effective coordination at the national, provincial and district (project site) levels in Lao PDR, a joint project steering committee was established to

supervise the process. A chief technical advisor and expert team also was in place for project planning and implementation. Main project components were further developed into concrete activities, such as land use planning, community-based restoration and rehabilitation of degraded forests, forest law enforcement, and trans-boundary biodiversity conservation. It is anticipated that these project activities will help reverse the trend of deforestation and forest degradation, promote sustainable management of forest ecosystems and sustainable development of local communities in northern Lao PDR, and contribute to the achievement of Lao's National Growth and Poverty Eradication Plan and Forest Strategy 2020.

### - Comparative Analyses of Transitions to Sustainable Forest Management and Rehabilitation

The project has produced valuable research results which identified underlying drivers of deforestation and forest degradation and also showed the encouraging improvement of forest rehabilitation and SFM in China, India, Indonesia, Japan, Korea, Lao PDR, Malaysia, the Philippines and Viet Nam. The project also analysed those drivers in their broader socioeconomic context and summarized common trends of forest cover change in the Asia-pacific region.

#### 4. Sydney Goal Assessment

To mobilize APEC economies to promote regional forest resources information sharing and work together to identify the efforts made towards achieving the APEC 2020 forest cover objective, the program "Assessment of the Progress towards the APEC 2020 Forest Cover Objective" was agreed upon by APEC Senior Officials at their first meeting (SOM1) in Ningbo, China in February 2014. APEC Senior Officials approved the program "Assessment of the Progress toward the APEC 2020 Forest Cover Objectives" at their first meeting (SOM 1) in Ningbo, China in February 2014 in order to mobilize APEC economies to promote forest resources information sharing and to work together to identify the efforts that have been made toward achieving the 2020 objective. This initiative was subsequently included as one of the actions in the APEC Tasking Statement for 2015.

#### V. Capacity Building

#### **Background**

Thematic workshops were initiated in 2009 under APFNet's pillar of Capacity Building and aim to improve the capability of regional policymakers and practitioners through sharing knowledge and practical experiences of sustainable forest management.

Two hundred forestry officials from 18 economies in the Asia-Pacific region have benefitted from APFNet's training workshops since 2009. This fulfils the goals established in the APFNet strategic plan 2011-2015: i.e. a minimum of 150 regional forestry officials and practitioners with enhanced knowledge and skills from APFNet's training courses. Questionnaires were distributed at the end of each workshop to assess the level of communication and understanding among participants and to obtain their feedback and suggestions on the organization and design of activities.

Launched in 2010, the APFNet Scholarship Program (ASP) under the Capacity Building pillar aims to support the new generation of foresters of developing economies in the Asia-Pacific region to pursue higher education at the postgraduate level. The ASP offers a two-year Master's program in three majors: Forest Economics and Management, Forestry, and Forest Engineering and Environmental Science. Students were selected according to APFNet application procedures through the Focal Points Mechanism.

By now, a total of 46 students have been admitted into the program, and 24 have graduated. Most of the graduates work in various specialist positions in governmental agencies, international organizations and research institutions. Several of them are pursuing the PhD degree in, for example the United Kingdom, Japan and China. ASP has not only provided opportunities for foresters in the Asia-Pacific region to pursue advanced studies, but also enhanced students' understanding of the experiences and achievements of forestry development of China.

#### Work progress 2014

#### 1. Thematic training workshops

APFNet's thematic workshops on Degraded Forest Rehabilitation and Sustainable Forest Management (under theme of Forest Resource Management) and Forest Biodiversity Conservation and Improvement of Rural Livelihoods (Under the theme of Forestry and Rural Development) were held in July and November 2014 in Kunming, China. Thirty regional forestry officials and practitioners working in the two topic fields were invited to the workshops. Each ten-day workshop features lectures through which participants understood the current state of rehabilitation of degraded forests and forest biodiversity conservation in the Asia-Pacific region. The participants were also provided with opportunities to share their experiences on rehabilitation and forest biodiversity conservation in their own economies, particularly drawing upon successes and failures of those approaches to guide the development of future policies.

#### 2. APFNet Scholarship Program

Beijing Forestry University (BFU) and Nanjing Forestry University (NFU) are the

host universities for ASP currently. The eight ASP students who enrolled in 2012 fulfilled their two-year master's degrees at BFU and graduated in July 2014. Seventeen students from Bangladesh, Cambodia, Nepal, Lao PDR, Myanmar, Malaysia, Papua New Guinea, and Pakistan were admitted to the ASP in September 2014.

3. Workshop on Forestry Human Resources Development in the Asia-Pacific Region, *Bogor, Indonesia*, 25-27 Nov

Cooperating with the Forestry Extension and Human Resources Development Agency of the Ministry of Environment and Forestry of Indonesia, APFNet co-organized the workshop in Bogor, Indonesia. It gathered 45 representatives from 16 developing economies and RECOFTC to review the status quo and discuss the challenges of forestry human resource development and, in particular, on-the-job training in the region. The participants agreed to establish a Dialogue on Forestry Human Resources Development in the region in order to strengthen networking among forestry training and capacity building institutions and explore possible cooperation in the region.

#### VI. Information sharing

Realising the importance of winning support from its current and potential donors, APFNet increased its effort to publicize itself in its host economy in 2014. Meanwhile, APFNet also took advantages of opportunities at international conferences to showcase its activities and efforts to a wider audience.

#### Work progress 2014

1. Strengthened project promotion and dissemination

Strengthening the promotion of APFNet and increasing the level of project dissemination among donors of APFNet were of high priority in 2014. This was achieved in the regular release of feature stories on projects (in Chinese) including the "Demonstration of Sustainable Upland Agroforestry Systems in Chinese Taipei", "Sustainable Forest Rehabilitation and Management for the Conservation of Trans-boundary Ecological Security in MMSEA" and "Forest Cover and Carbon Mapping in the GMS".

Furthermore, feature stories on the progress of the Multifunctional Forests pilot project and the regional workshop on strategic forestry cooperation in Greater Central Asia were reported in Green Times, a major forestry news platform in China. An English edition of the APFNet newsletter was also released, featuring stories on key projects including the APFNet Scholarship Program, Thematic Training Workshops and two climate change projects. The newsletter also provided updates on the progress and results of other projects as well as notes on

upcoming activities.

#### 2. Participation in external conferences and events

To boost APFNet's presence in the international forestry community and to foster future partnerships, APFNet participated in three international conferences this year: the International Union of Forest Research Organizations (IUFRO) World Congress in Salt Lake City, USA; the International Union for Conservation of Nature (IUCN) World Parks Congress in Sydney, Australia; and the United Nations Convention on Climate Change Conference of Parties (UNCCC COP20) in Lima, Peru. Exhibitions were set up to present our capacity building and demonstration projects as well as distribute various publications completed over the year.

In addition, two exhibitions were set up in the China State Forestry Administration (SFA) building. One focused on the development of APFNet over the past five years, while the other was displayed during an international cooperation meeting hosted by the SFA. Finally, an exhibition was set up during the APEC Senior Officials' Meeting in November in Beijing, China.

3. APFNet partnered with China's Experimental Center for Tropical Forestry (ECTF) to compile and publish eight case studies on successful Close-to-Nature forestry management methods, with the objective of regional and international dissemination. This was the first time that APFNet took on the leading role to coordinate a publication partnership. The report is currently in the final stages of revision and will be published in the first half of 2015.

#### 4. APFNet 2013 Annual Report

The annual report showcased APFNet's work during 2013. The report is available in English.

#### VII. Administration and operation

As a young organization, APFNet is still adjusting and completing its administrative and operational procedures to improve efficiency and effectiveness of the work within Secretariat as well as its communication with stakeholders.

#### Work progress 2014

1. Improvement to internal working procedures

APFNet began development of the Communications Guideline (CG), which is intended to strengthen communications between project executing agencies (EAs) and the APFNet secretariat. The CG establishes a working procedure for gathering ongoing project updates, creates quality standards for the submission of

photos from EAs, and lays out schedules for regular publishing of updates on the APFNet website and transmission to AFPNet members and focal points. A series of training workshops on project communication is also under planning and development.

2. APFNet has been developing its Intranet Platform which aims to streamline internal procedures and support decision-making. The platform will automate office administration, communications and project management. The system is currently in the last stages of development and is expected to launch in the near future.

#### VIII. Financial information for the year 2014

APFNet total revenues in 2014 was CNY 27,854,943.93, approximately 4.45 million US\$ (1 US\$= 6.1190 CNY on Dec 31, 2014) as shown in table 2. The total expenditures in 2014 were CNY 20,454,897.39, approximately 3.34 million US\$.

According to the category breakdown shown in Table 3, 73.73% of expenditures in 2014 were devoted to the activities of pilot projects, capacity building, policy dialogues and communication and information sharing. Around 26.27% of expenditures were allocated to administrative costs (including staff, equipment, vehicle, office rent, and office operations.)

#### Work plan and annual budget 2015

#### I. Institutional Development

Consistent with the long-term arrangements in the Strategic Plan 2011-2015, the permanent governance bodies, i.e. the Board and Council, will be launched in 2015 to formalize APFNet's operation. In the first half of the year, the establishment and the first meetings of the two bodies will be convened to review key documents and administrative rules related to APFNet's development.

#### **Board**

1. Finish appointment of the Directors

Projected output: List of Board of Directors

2. Prepare the documents of the Board

Projected output:

- a) Work report 2014 and work plan 2015 of APFNet;
- b) Draft framework of the strategic plan 2016-2020 of APFNet;
- c) Procedures for the Development of APFNet Membership;
- d) Framework Document of the Staff Regulations;
- e) Framework Document of the Financial Regulations.
- 3. Convene the First Meeting of the APFNet Board

As the decision-making body of APFNet, the Board will first review and adopt their rules of procedure, make suggestions for the strategic planning for the next five years and review or further amend major administrative rules of APFNet bodies under the new governance structure. The First Meeting of the APFNet Board is scheduled in early April.

#### Council

1. Collect appointments of the Council representatives and contact person(s)

Projected output: List of Council members

2. Prepare the documents of the Council

Projected output:

- a) Rules of Procedure of the Council;
- b) Terms of Reference of the Project Appraisal Panel;
- c) Decisions of the Board at its first meeting.
- 3. Convene the First Meeting of the APFNet Council

Members were asked to appoint Council representatives by 10 February. To formally establish the Council, the first meeting of APFNet Council is scheduled in late April, which will discuss and give recommendations to APFNet following the meeting agenda and according to the responsibilities of the Council.

#### II. Membership

In light of the establishment of the Board and Council, the transitional Procedures for the Development of APFNet Membership also needs to be updated, revised and applied to the processing of new membership applications.

#### III. Partnerships

APFNet will continue to work with its partners to craft joint efforts to promote sustainable forest management in the region. It is necessary to develop a plan to review current partnerships, find possible collaboration on activities/research and seek partners with shared interests. APFNet will also consult with those partners whose MoU's will expire within the year about possible renewal and extension of the partnership.

#### IV. Policy Dialogues

Valuing the effective role of policy dialogues in elevating forestry's profile and promoting sustainable forest management, APFNet will continue to leverage the APEC platform to gather forestry ministers, and remain involved in other platforms such as ASEM and GMS to foster political commitment to forestry.

1. Organize the Third APEC Meeting of Ministers Responsible for Forestry In line with the Cusco Statement to further promote forestry cooperation among APEC economies and to encourage progress towards leader's statements with respect to sustainable forests, as the initiator and sponsor of the APEC forestry ministerial meetings, APFNet expects to bring forestry ministers of the APEC economies together for a third meeting to discuss major forestry policy issues and carry forward momentum of the previous two meetings to uplift forestry's profile and advance sustainable forestry development in the APEC region.

Projected output:

- a) Third APEC Meeting of Ministers Responsible for Forestry convened;
- b) Forestry minister's declaration

#### V. Platforms for information exchange

#### Promoting forestry cooperation in Greater Central Asia Economies

- Organize study tours by the APFNet secretariat to Central Asia economies to learn about the experiences and lessons learned in aspects of vegetation restoration in arid and semi-arid areas, combating desertification, sand industry development and so forth and to explore potential cooperation opportunities between Central Asia economies and APFNet.
  - Projected output: Study report presenting potential cooperation opportunities in forestry sectors.
- 2. Building on the achievements of the previous workshop, the Second Regional

Workshop on Strategic Forestry Cooperation in Greater Central Asia will be organized in September 2015 in Mongolia in collaboration with Ministry of Environment, Green Development and Tourism of Mongolia.

#### Projected output:

- a) Consensus reached during the first workshop will be promoted, including establishing Technical Group of Greater Central Asia, establishing Central Asia Forestry Ministerial Meeting Mechanism, strengthening the mechanism of Regional Workshops on Strategic Forestry Cooperation in Central Asia;
- b) Potential cooperation opportunities identified during the study tours will be shaped into concrete proposals.

#### VI. Projects and programs

From February to April, 2014, APFNet opened its annual Call for 2015 Project Proposals. Twenty-five project concept notes were submitted from a wide range of economies, institutes and organizations within the Asia-Pacific region. After appraisal, six projects were selected for 2015 APFNet funding.

APFNet will continue to work with the executing agencies to ensure the successful implementation of current projects. A workshop is planned to enhance networking, experience sharing and project guidance among project partners. #### Sydney Goal assessment

The APFNet Secretariat will formally initiate the Program on "Assessment of the Progress towards the APEC 2020 Forest Cover Objective" by:

- 1. Distributing the concept paper and report outline to all APEC economies.
- 2. Cooperating with FAO/RAP, send statistical data on forest area to each APEC economy respectively for their report preparation.
- 3. Collecting economies' reports by the end of May 2015 and synthesize the reports into an integrated one with assistance from relevant experts.
- 4. Sending back the integrated report to each economy for authorization and final submission to the APEC Secretariat in October 2015.

#### Strategic Plan 2016-2020

- Draft the Framework of the APFNet Strategic Plan 2016-2020 with the assistance
  of the chief consultant for the Board's review. Based on the Board's
  recommendations and suggestions, the draft of the Strategic Plan will be
  developed.
- 2. Organize a consultation meeting for reviewing and improving the draft of the Strategic Plan.
- 3. Send the improved draft to the Council for comments and recommendations
- 4. Finalize the draft following the comments and suggestions from the Council
- 5. Submit the finalized strategic plan to the Board for approval
- 6. Release the APFNet Strategic Plan 2016-2020 by End 2015 or early 2016

#### VII. Capacity Building

- 1. Improving the Dialogue on Forestry Human Resource Development in the Asia-Pacific region
  - Conducting separate case studies on human resource development in the forest sector of economies in the Asia-Pacific region and summarizing relevant experiences for strengthening the institutional capacity of forestry agencies.
  - Projected output: Case studies on human resource development in the forest sector
- 2. Organize a side event on the forestry online course development project at the 14<sup>th</sup> World Forestry Congress; hold a discussion among the Steering Committee colleges on the institutional arrangements and next steps for the Forestry College Deans Meeting Mechanism in the Asia Pacific Region (FCDMM-APR)

  Projected output: Promote the progress of the online course development project and identify the next steps on the FCDMM-APR
- 3. Organize the Fourth Forestry College Deans Meeting in the Asia-Pacific Region Projected output:
  - a) Fourth Forestry College Deans Meeting in the Asia-Pacific Region convened

and the forestry online course development project completed with the six forestry online courses launched;

- b) Summary report of the Fourth Forestry College Deans Meeting in the Asia-Pacific Region.
- 4. Organize thematic training workshops in early July and in November. Projected output:
  - a) Two thematic training workshops convened;
  - b) One report from each workshop.
- 5. To achieve the objective in the Strategic Plan 2011-2015 -- a minimum of 60 scholarships provided -- the APFNet Scholarship Program will support another 15-20 students from the developing economies in the region to study for a Master's degree. APFNet and the two host universities will provide expanded opportunities for field study and practice of forestry to the scholarship students. Project output: 15-20 students sponsored by the ASP and admitted to the host universities

#### VIII. Information sharing

- In 2015, APFNet will continue to provide support for dissemination and outreach
  to ongoing projects and other institutional activities. APFNet will also consider
  ways to build strategic partnerships with external organizations and expand
  APFNet's communication network. To-date, this includes event organization and
  participation in the 14<sup>th</sup> World Forestry Congress in Durban, South Africa.
- 2. APFNet will also further explore channels of dissemination that would expand the reach of our technical publications, such as publishers of academic journals and international forestry publications.
- 3. Prepare the APFNet annual report 2014 (English)

#### IX. Annual budget

In 2015, around CNY 51,143,919.64, equivalent to US\$ 8.36 million, (the exchange rate is 6.1190 on Dec 31, 2014) will be available to support all kinds of activities of APFNet.
