# APFNet Progress and Financial Report 2015

This report highlights the achievements of APFNet in 2015 against the annual work plan which the Council recommended and the Board approved. It covers the last year of the first APFNet Strategic Plan (2011-2015). Generally, APFNet has

- (1) improved its institutional governance to obtain more regional input in terms of its development;
- (2) refined policies and procedures to regulate its operations; and
- (3) strengthened the planning and monitoring of activities and projects to deliver higher quality outputs/outcomes that result in wider impacts and positive change.

# I. APFNet Strategic Plan (2016-2020)

Following the recommendation of Council and decisions of the Board, APFNet Secretariat developed its second Strategic Plan which carves out APFNet's niche and identifies its priorities for contributing to forestry development in the region. While maintaining APFNet's vision, mission, objectives and structure of the first Strategic Plan, the current draft focuses on rehabilitating degraded forests and on improving livelihoods/alleviating poverty through sustainable forest management (SFM). In line with its mandate, the 4 pillars on which APFNet is founded will be retained: capacity building, information sharing, regional policy dialogues and demonstration projects. In addition, the objectives, priorities and implementation tools will be linked more closely, clearer indicators will be established and the monitoring of performance will be enhanced.

## II. Institutional Development

The establishment and inaugural meeting of APFNet's Board of Directors in Beijing (China) on 8 April and the establishment of APFNet's Council and inaugural meeting in Nay Pyi Taw (Myanmar) on 27-28 April are milestones in the organization's institutional development. With the Board acting as the decision-making body and the Council functioning as the advisory body, a formal governance structure is now in place, thus confirming APFNet's status as an international entity.

The Board consists of 14 directors who elected Mr. ZHAO Shucong as its first Chair. It adopted Rules of Procedure and reviewed the following documents: (1) Framework for the APFNet Strategic Plan (2016-2020); (2) Procedures for the Development of APFNet Membership; (3) Framework Document of Staff Regulations; and (4)Framework Document of Financial Regulations. It also authorized the Secretariat to develop detailed plans and procedures.

The Council consists of representatives from 31 APFNet members who elected a Chair from Thailand and Vice-Chair from Papua New Guinea. It adopted Rules of Procedure and recommended that revision be made to the following documents:

(1)Procedures for the Development of APFNet Membership; (2) Terms of Reference for the Project Appraisal Panel; and (3) Draft Framework for the APFNet Strategic Plan (2016-2020). Subsequent email correspondence led to the adoption of the Procedures for the Development of APFNet Membership.

APFNet initiated a process to expand regional representation on its Secretariat by first hiring professional foresters as interns for project management, upon the recommendations of Cambodia and Laos. Australia also expressed willingness to second staff.

# III. Partnerships

The goal of developing and maintaining partnerships with other international/regional organizations is to achieve mutual benefits through close collaboration, building on respective comparative advantages to avoid duplication.

APFNet renewed its Memorandum of Understanding (MoU) with RECOFTC to continue their collaboration on community-based forestry management in the region. Its MoU with FAO allows APFNet to offer ongoing support for FAO's short policy course in the region and facilitates its involvement in the Asia Pacific Forestry Week as one of five key players, the most recent one having taken place in the Philippines. The benefits of APFNet's association with ITTO include the sharing of expertise and resource persons for training and support to a project which APFNet is funding on community-based sustainable forest management in the Sungai Medihit Watershed, Sarawak (Malaysia). In this instance, ITTO is the Supervisory Agency. The All-China Women's Federation (ACWF) is a new partner - a development which underscores the important role that women play in forest resource management in the region.

## IV. Support to Regional Policy Dialogues

APFNet works with international mechanisms/regional organizations to bring policy makers and practitioners together to discuss common issues and identify solutions. It has also established new mechanisms/networks that facilitate policy dialogues and collaboration - ones that reflect the unique features and diverse conditions found in the Asia-Pacific region.

# 1. Support for the Third APEC Meeting of Ministers Responsible for Forestry, 27-29 October, Port Moresby, PNG

The APEC Meeting of Ministers Responsible for Forestry is the only senior level gathering that promotes forest policy dialogue and cooperation in the region. APFNet continued to provide technical and financial support, including to develop the agenda and program, draft an outcome statement, recommend resource persons and advise on logistics and social events.

More than 200 delegates from 18 APEC economies attended the third meeting, including ministers and high level officials. They adopted the Eda Statement ("Our Statement" in the local language) which recognizes the importance of forests to the livelihoods of forest-dependent people and the role of forests in climate change mitigation and adaptation. The document calls for strengthening cooperation among APEC economies to tackle key issues such as policy development, illegal logging and trade, and cross-sectoral coordination. It also encourages APEC economies to share information and best practices through APFNet to support sustainable forest management in the region.

2. Assessment of Progress towards the APEC 2020 Forest Cover Goal With support from FAO and APEC member economies, assessment of the progress toward reaching the goal of 20 million hectares of forest cover by 2020 was successfully concluded. The report shows that forest area is increasing and the quality of forest management is improving in most APEC economies. From 2007 to 2015, it grew by 15.4 million hectares to reach 2.19 billion hectares, achieving an estimated 77% of the goal. Also over the same period, most economies have increased their forest stock per hectare and total forest stock. Given these findings, APEC economies should be reasonably confident that they will reach the APEC 2020 objective for forest cover.

The report was acknowledged in the concluding statement of the 2015 APEC meeting of senior officials and outcomes were included in the Joint Ministerial Statement. Leaders welcomed the results of the assessment in their 23rd declaration entitled Building Inclusive Economies, Building a Better World: A Vision for an Asia-Pacific Community.

3. Strategic Framework for Forestry Cooperation in Greater Central Asia Building on the first workshop in 2014 to promote sustainable forest management in the Great Central Asia region, APFNet co-organized a second workshop to discuss strategic collaboration, from 15 to 17 July, in Ulaanbaatar (Mongolia). Participants exchanged information on the current status, trends and constraints for forest management and on best practices to prevent forest fires, combat desertification, develop a sand industry and improve rural livelihoods. They also approved a plan to convene meetings of ministers responsible for forestry in the region, hold workshops on strategic cooperation, initiate demonstration projects and implement capacity building programs. Kazakhstan proposed to host the first ministerial meeting, while Kyrgyz offered to host the third workshop on strategic cooperation.

As a concrete follow-up to the session in Ulaanbaatar, APFNet organized a regional workshop which took place 22-29 September, in Inner Mongolia (China). Forestry department officials met to discuss ways to combat desertification and improve livelihoods. Classroom lectures and field tours were both highly appreciated. In addition, the event helped APFNet to better understand issues that the region faces

and will use this information for planning future activities and projects.

# V. Projects and programs

Special attention was paid to project planning and monitoring, technical inputs were enhanced, and the period for project development was lengthened, especially for trans-boundary and long-term projects, to allow them to identify clear objectives, develop detailed and realistic annual work plans, and identify measurable indicators for monitoring progress. APFNet also enhanced its guidance to projects on planning and reporting and it increased the frequency of communication and on-site visits to monitor the status of projects, how partners were helped to enhance their communication skills, how their capacity to plan and implement projects improved and how well they were able to report on deliverables when the project ended.

In 2015, APFNet provided USD4 million to 8 projects which addressed issues related to integrated watershed management, rehabilitation of degraded forests, multipurpose forestry, monitoring of forest cover change and the development of national SFM plans. Please see annex2 for details.

# VI. Capacity Building

# 1. Thematic Training Workshops

Two thematic training workshops were convened in 2015: Enhancing Forest Governance for Asia and the Pacific in the Context of Timber Legality Verification (2-13 July in Yunnan, China.) and Biodiversity Conservation Challenges in the Asia-Pacific: the Trans-Boundary and Livelihood Dimensions (1-13 November in Chiang Mai, Thailand). This second event was hosted by the Royal Forest Department of Thailand, in response to suggestions to hold some training sessions outside China. APFNet sponsored about 30 regional forestry officials and practitioners who shared their experiences on the topics. They identified the importance of implementing transparent mechanisms to monitor trade in legal timber and timber products in the region and indicated that the workshop provided a significant platform for sharing knowledge in this regard. Outcomes of the workshop on biodiversity conservation across boundaries, as it affects rural livelihoods, will pave the way for enhancing collaboration in the Asia-Pacific region.

APFNet's Training Centre in Kunming (China) organized both workshops, with support from APFNet and Southwest Forestry University. In 2015, the Centre was provided facilities, staff was put in place, and a 5-year plan for APFNet training (2016-2020) was developed to better meet regional needs for capacity building.

## 2. APFNet Scholarship Program

Twelve scholarships were awarded to applicants from Cambodia, Lao PDR, Mongolia, Myanmar, Nepal and Sri Lanka, 8 of whom studied at Beijing Forestry University and

4 at Nanjing Forestry University. Five students who enrolled in 2013 completed their master's degrees in Beijing and graduated in July 2015.

The Secretariat conducts regular evaluations, the results of which indicate that students were generally satisfied with the course design, supervisors and on-campus management. However, it was suggested that course materials could be updated and more field study could be offered.

## 3. Human Resources Development

A regional seminar on the development of human resources in the forestry sector was held 25-31 October, in China. Some 14 participants from 12 developing economies explored the best means to enhance cooperation through regional networks. Discussions focused on the national forestry training systems in each economy and on ways to strengthen them across the region. Obstacles that the Asia-Pacific must deal with include weak capacity to offer high quality training programs, sound career development, effective succession management, and meaningful competency standards. Other problems include the fact that decision-makers treat the forestry sector as a low priority, forest issues are complex and much needed financial support is not forthcoming. However, some economies are able to overcome such challenges.

# VII. Information sharing and communications

## 1. APFNet Communications Guide

Developed for Secretariat staff, project executing agencies and partners, this document provides guidance, templates and tools to develop communication strategies and work plans for APFNet activities. A training course was delivered to staff in October and another one was given to executing agencies in November.

### 2. Outreach events

World Forestry Congress, 7-11 September 2015, Durban (South Africa): APFNet hosted 3 side events and staffed a booth in the exhibition hall. This presence helped to raise APFNet's profile and visibility amongst international policy makers, foresters, researchers and other important stakeholders.

Asia-Pacific Forestry Week, 22-26 February 2016, Clark Freeport Zone, Philippines: More than 200 people attended this gathering which comprised 16 events and 100+ presentations. As requested by FAO-RAP, APFNet and AFOCO co-organized Our Green Future: Green Investment and Growing Our Natural Assets - a session which examined issues related to green investment and sustainable forest management in the Asia-Pacific Region.

## 3. Publications

A report was written on forest transition in the Asia-Pacific region; flyers and brochures featuring technologies were produced by the project Adapting Asia-Pacific

Forests to Climate Change; and the APFNet annual report was published, along with various newsletters.

# VIII. Administration and operation

The Secretariat made internal adjustments to the division of work to improve its capacity to serve APFNet's Board and Council, improve the exchange of knowledge and information, and strengthen collaboration with APFNet members on project implementation.

In accordance with Council suggestions and Board decisions, the Secretariat drafted guidelines to standardize its operations with regard to staff, administration, finances, and the criteria for selecting an Executive Director. This document will be presented to the Board of Directors for approval.

Staff training and development remain a priority. Academic lectures and study tours were regularly organized to keep abreast of the current state of forestry in the region. Training was also held to improve communication and coordination. The system to assess staff performance was revamped to include a review of their accomplishments against annual work plans and the introduction of intranet has, to a large degree, streamlined internal procedures and supported decision-making.

#### IX. Finance

Revenues in 2015 totalled CNY 28,656,206.03 or approximately USD4.41million (1USD=6.4936CNY at the exchange rate issued by The People's Bank of China on 31 December 2015). Expenditures in 2015 were CNY 28,918,053.61 or approximately USD4.45 million. A statement of APFNet's financial position, a statement by item and supplementary schedule of APFNet expenses are provided below.

# **APFNet Annual Work Plan and Budget 2016**

This document presents APFNet's work plan and budget for 2016.

# I. Institutional development

- 1. According to their respective mandates, the Board of Directors and Council will continue to provide direction and advice on APFNet's development by considering and approving its work plans and other initiatives that may be proposed at the second meeting of the Board and Council in May. Specifically, it is hoped that:
  - a) the APFNet Strategic Plan (2016-2020) will be adopted to direct and monitor activities over the next 5 years;
  - b) the APFNet Operations Manual that regulates the staffing, administration and financial management of the Secretariat will be adopted; and
  - c) a new Project Appraisal Panel for 2016-2018 will be established, with regional representation, to provide high quality technical advice to APFNet on project concept notes and full submissions.

The Secretariat continues to facilitate the preparation of Board and Council meetings and, as expected, will take the lead in implementing approved procedures.

# 2. Communication with the Board and Council

Communication with the Board and Council will be more frequent between meetings to better inform them of APFNet operations.

#### 3. Secretariat

In efforts to create a diverse and multi-cultural environment, 1 intern from each of Lao and Cambodia will work with the Secretariat for a year. The Secretariat will also explore the possibility of staff secondments and/or exchanges with Australia and other partners.

# 4. Other institutional matters

In accordance with relevant rules of procedures, the Secretariat will continue to support regular institutional work, including extending the term of Directors and preparing for the third meetings of the Board and Council.

# II. Partnerships

# 1. Memoranda of Understanding (MoU)

As planned, a MoU between APFNet and ITTO will be renewed to continue joint efforts to achieve SFM in tropical areas through projects and other activities. The signing of a MoU with IUFRO will offer mutual support to the work of the 2 organizations and, given that the IUFRO Regional Congress for Asia and Oceania will be held in October in China, opportunities for close cooperation will be explored, including joint training for APFNet scholarship students.

2. Annual plans will be developed and more frequent communication will be made with partners to identify the scope for closer collaboration on activities of mutual interest.

#### APFNet reception

At the end of the year, the Secretariat will host a major social event for representatives from APFNet member economies and partners residing in China to present its 2016

achievements and an outlook for 2017.

# III. Regional policy dialogues

1. Meetings of APEC ministers responsible for forestry

Meetings of APEC ministers responsible for forestry are the highest level of policy dialogue in the region and serve as a primary forum to transform political will into action. APFNet actively participated in previous meetings through joint organization, development of themes, and the production of outcome documents. The Secretariat will work with member economies to identify a host for the 4th ministerial session and will seek ways to secure long-term support for this forum.

2. Ministerial dialogues on forests in Greater Central Asia

During a workshop in Mongolia in July 2015 to discuss strategic collaboration on forestry issues in Greater Central Asia, a plan was made to convene regular meetings of ministers responsible for forestry in the region. APFNet will financially support and coordinate this first meeting which Kazakhstan will host on 30-31 May 2016. Discussions will focus on strengthening bilateral and multilateral cooperation in forestry and on mainstreaming the sector in socio-economic development plans. A ministerial statement is expected to be adopted to outline concrete steps to achieve goals.

3. The Asia-Pacific Forestry Strategic Planning Network (originally proposed as the Forestry Strategic Planning Mechanism in 2013) focuses on strengthening the development and implementation of forestry strategies and master plans in APFNet member economies. The network will be redeveloped, following consultations with the APFNet Council, to identify objectives and formulate an operations strategy.

## IV. Demonstration projects

1. Project planning and design

Focusing on its priorities for 2016-2020, while responding to the needs of member economies, APFNet will continue to support regional consultation and research to foster project planning. The new Project Appraisal Panel, soon-to-be established, will lead efforts to screen projects and provide greater technical inputs to project design by, for example, participating in feasibility studies to ensure promising concept notes are developed into pragmatic proposals that deliver solid results. The Secretariat will organize 2 meetings of the Panel and, as necessary, arrange study tours to assess the feasibility of proposals and facilitate the development of those deemed worthy.

Timeframe:

- (1) February: call for project concept notes
- (2) February-April: submission of project concept notes
- (3) May: establishment of the Project Appraisal Panel for 2016-2018
- (4) End of June: screening of concept notes
- (5) July-October: development of proposals
- (6) End of October: review of proposals and recommendations for support
- 2. Project management, monitoring and evaluation

The Secretariat will continue to guide the development of project work plans to ensure they are consistent with the approved submissions and are implementable. Through meetings and on-site visits, it will also provide training and support to enhance project capacity to plan, implement and report on activities. In addition, the

Secretariat will develop a robust monitoring and evaluation system to increase the effectiveness and efficiency of project management and its potential impacts. Missions to complete a final evaluation of 4 projects will be organized.

A summary of best SFM practices and successful models for restoring degraded forests, based on the outputs and achievements of APFNet's demonstration projects, will be shared.

# V. Capacity building

# 1. APFNet Scholarship Program

APFNet will fund about 20 more students from the region to attend Beijing Forestry University and Nanjing Forestry University in either of the four disciplines offered: Forest Economics and Management; Forestry; Forestry Engineering; and Environmental Engineering. Some 16 students will complete studies and defend dissertations for their Masters' degree.

Building on the results of APFNet's annual review in 2015, guidance will be given to the host universities to improve the current program by (1) diversifying teaching approaches through more group work, field visits and interaction with forest practitioners and (2) extending assessment of the program to include its impact on the graduate's career development.

APFNet will continue to allow campus students to access its training bases and demonstration sites so they may gain field experience on forest management.

## 2. Thematic training workshops

Under APFNet's training plan for 2016-2020, greater effort will be made to combine theory and practice, improve the selection of appropriate resource persons and participants, and develop training materials in series and lecture formats. The APFNet Kunming Training Center will lead program development and applicant selection for workshops to be held in China (July) and in Sri Lanka (November).

### 3. Capacity building

APFNet, in collaboration with partners in Inner Mongolia (China), will organize a workshop entitled "Combating Desertification and Sustainable Management of Drylands Ecosystem towards Livelihoods Improvement" which will take place in September. In addition, it will plan a study tour to China for directors working in Greater Central Asia to learn about successful practices related to sustainable forest management, forest tenure reform, community-based forest enterprises, transboundary biodiversity conservation, forest fire prevention, and pest control in arid and semi-arid areas. Also, a comprehensive needs assessment will be launched to identify key stakeholders, issues of concern, appropriate channels to follow, and other elements which will help to develop a strategy to build capacity in the region.

4. The Asia-Pacific Forestry Education Coordination Mechanism
Formerly known as the Forestry College Deans Meeting Mechanism, this re-named
entity will continue to engage forestry educators and institutions to improve the
quality of education and strengthen capacity in the region. As chair of the mechanism
and host of its executive office since 2016, the University of British Columbia will
undertake the following activities, with the support of APFNet:

- (1) Prepare an annual report on current trends and emerging challenges in forestry education;
- (2) Certify previously developed online courses;
- (3) Facilitate mutual recognition of courses in regional institutions;
- (4) Develop of new project proposals;
- (5) Establish a regional forestry expert database;
- (6) Organize youth programs; and
- (7) Expand and promote its institutional capacity, including by recruiting new members and raising funds.

## 5. Development of human resources

Proposed in 2014, this program focuses on raising the capacity and knowledge of agencies and personnel responsible for providing foresters with the skills they need to perform their duties. APFNet, in collaboration with partners, will suggest changes to the program's objectives, strategies and work plans. Activities foreseen include:

- (1) Consulting with the APFNet Council for feedback and direction;
- (2) Conducting a needs assessment;
- (3) Organizing consultation workshops; and
- (4) Developing networks and working with experts and partners.

## VI. Information sharing

The Secretariat will continue to update APFNet's website, release regular newsletters and publish materials to share notable project outcomes. It will also make efforts to strengthen the communications component in new project proposals and work with executing agencies to integrate this aspect into current projects. Additional opportunities will be sought with external publishing houses and other international organizations to produce joint publications.

In 2016, the Secretariat plans to organize additional outreach activities to raise its profile and promote major projects. In this regard, it will set up exhibitions at international conferences such as the first meeting of ministers responsible for forestry in Greater Central Asia in Kazakhstan (May), IUCN World Conservation Congress (September), IUFRO Regional Congress for Asia and Oceania (October) and the United Nations Conference of the Parties to the Framework Convention on Climate Change (November).

## VII. Human resources and administration


The following tasks will be undertaken in 2016 with regard to the development of human resources and the administration of operational matters:

- 1. Review the organizational structure of the Secretariat and the job descriptions of all staff to ensure an optimal division of portfolios and workload;
- 2. Renew contracts of staff and experts;
- 3. Facilitate procedures for international interns to work in the Secretariat;
- 4. Monitor and assess implementation of the APFNet Operations Manual and relevant policies to improve staff efficiency and cost-effectiveness of operations;
- 5. Continue to provide regular training to general staff on forestry and management;

- 6. Identify additional opportunities for staff exchanges and/or rotations;
- 7. Encourage a learning and knowledge-sharing environment.

# VIII. Budget and resources

In 2016, about CNY63.05million, or USD9.71 million, (1USD=6.4936CNY) will be available to support the activities of APFNet. The budgets by category and by activity are detailed in the tables below.
