Waste management in Japan

- The businesses shall be required to manage of their industrial waste by themselves.
- The municipalities shall collect, transport and dispose of municipal solid waste (non-industrial waste) in their municipal areas.

(In case of the management of difficult solid waste)


 The municipalities are entitled to demand the cooperation of the businesses manufacturing, processing, selling or otherwise handling a product.

(Waste Management and Public Cleansing Law, 1970 Law No.137)

1. Processing flow of "Municipal Solid Waste" Industrial waste"





2. Volume of Used Tyres Generated










Recent trend is influenced by two laws:

 The law to mandate report of annual greenhouse gas emission.








5. Processing flow of Used Tyres' Recycling

7. JATMA Support Program for Dumping Site Restoration

- A program to promote a voluntary removal operation of ELT tyres by local government entities that was established and has been operating by the tyre industry since 2005.
- From 2005 to now, JATMA supported a total of about 362 million Yen in 22 cases and removed about 3 million ELT tyres.
