壹、 會議緣起

「亞太經濟合作」(Asia-Pacific Economic Cooperation,簡稱 APEC)係 1989年由澳大利亞總理 Robert Hawke 倡議而成立的亞太區域主要經濟諮商論壇,希望藉由亞太地區各經濟體政府相關部門官員的對話與協商,帶動該區域經濟成長與發展,成立時共有 12 個創始成員。我國係於 1991年加入 APEC,我以「Chinese Taipei」名稱與中國大陸及香港在該年同時加入 APEC。目前 APEC成員除我國外,尚有澳大利亞、汶萊、加拿大、智利、中國大陸、香港、印尼、日本、韓國、馬來西亞、墨西哥、紐西蘭、巴布亞紐幾內亞、秘魯、菲律賓、俄羅斯、新加坡、泰國、美國及越南總計 21 個會員體,各會員體均係以「經濟體」(Economy)身分參與。

APEC 科技創新政策夥伴 (Policy Partnership on Science, Technology and Innovation, 以下簡稱 PPSTI)係由原 APEC 工業科技工作小組 (Industrial Science and Technology Working Group, ISTWG)於 2012年改組而來。鑑於以往 ISTWG 核心方向較偏重於工業科技發展內容之分享交流,PPSTI 則強調政策工具在推動科技創新中發揮的效益,致力建構科技政策平台,以緊密結合政府、學術界及私人企業三方,希望透過科技決策之經驗交流及統合機制,推動一個有利創新的環境,以獲致亞太地區的創新成長 (innovative growth)。我國跨部會 APEC 策略小組會議自 PPSTI 成立以來,即指定本部科教國合司及經濟部技術處為我國參與 APEC PPSTI 活動之窗口。

PPSTI 自 2013 年開始運作,每年舉行 2 次會議。本次為第 10 次 PPSTI 會議,業於本(106)年月 5 月 11 至 13 日於越南河內 Viet Nam National Convention Center 舉行。PPSTI 第 10 次會議共計有 15 個會員體出席(除汶萊、墨西哥、秘魯、日本、紐西蘭、新加坡外),另邀請亞洲環太平洋大學(APRU)、香港、澳門共同參加。

越南為 2017 年 APEC 會議主辦國,本年度 APEC 主軸為「創造新動能, 育成共同未來 (Creating New Dynamism, Fostering a Shared Future)」,並設定四項 優先議題領域,包括「促進永續、創新及包容性成長 (Fostering Sustainable, Innovative and Inclusive Growth)」、「深化區域經濟整合(Deepening Regional Economic Cooperation)」、「強化微中小企業在數位時代之競爭力及創新(Strengthening MSMEs' Competitiveness and Innovation in the Digital Age)」及「改善糧食安全及永續農業以因應氣候變遷(Enhancing Food Security and Sustainable Agriculture in Response to Climate Change)」。

本年度 PPSTI 會議主題呼應 APEC 主軸,以「天然災害與科學防治」及「支持科技研發生態系穩健發展之政策分享,由其以能夠提升科技創業家精神、科技與公眾對話、支持科技研發人力資源發展(特別是青年及女性參與科學、技術、工程、及數學領域)為最」為本年討論重點。

本次會議針對分組主席進行改選,分組 A (Building Science Capacity)由馬來西亞擔任主席、中國大陸擔任副主席;分組 B (Promoting Enabling Environment for Innovation)由菲律賓擔任主席、秘魯擔任副主席;分組 C (Enhancing Regional Science and Technology Connectivity)由我方擔任主席、美國擔任副主席。

貳、會議過程及重要討論與決議事項

第 10 次 PPSTI 會議由美國國務院 Lisa Brodey 女士擔任主席、中國大陸科技部陳霖豪副司長及本年度主辦國—越南科技部 Le Thi Viet Lam 女士擔任副主席,另由 Nicholas Brooke 先生及 PPSTI Program Director Bernard Li 分別代表企業諮詢委員會(ABAC)及 APEC 秘書處出席本次會議。本次會議重點如下:

- 一、明年度 APEC 計畫申請之評分作業及方式將進行變革,詳細方案將待本 年下半年度資深官員會議決議後另行通知。
- 二、經濟及技術合作指導委員會全體小組(SOM Steering Committee on ECOTECH Committee of the Whole, SCE-COW)建議 PPSTI 應提出較宏觀之計畫,以議題整合個別新提案及現有計畫,使 PPSTI 更聚焦於重點議題發展。
- 三、 秘書處將持續於 PPSTI 官方網站更新 APEC Centers 動態及各計畫活動訊息, 請各中心連絡人及計畫執行單位將相關訊息彙整後一併送交 PPSTI

秘書處。

- 四、 ABAC 代表 Mr. Nicholas Brooke 提案表示,因現存計畫及新提案數量過多無法聚焦,建議 PPSTI 應針對現階段問題進行改善。此外,本年7月 ABAC 將於加拿大多倫多舉行年會,屆時將挑選 PPSTI 2~3 個提案對 ABAC 進行報告。
- 五、本年度 ASPIRE Award 徵選共計有 17 個會員體代表參與,為 ASPIRE Award 設立以來最多會員體參賽之紀錄,本屆 ASPIRE Award 徵選主題為「先進材料(Advanced Material Technology」,我國推薦國立清華大學材料工程學系關郁倫教授代表。經激烈競爭與評選,由中國大陸推薦之代表中國科學技術大學朱彥武博士獲得。朱博士在石墨烯及其他新型碳材料、奈米材料及高性能能量轉換研究上獲得評審團肯定,其相關著作亦發表於各大國際學術期刊,研究能量卓越,故獲選為本年度 ASPIRE Award 得獎人。
- 六、 PPSTI 主席表示,將於明年度實施知識夥伴(Knowledge Partner)制度, 擬制定年度科技創新主題並邀請私部門代表參加,結合業界經驗共同擘 劃未來科技創新發展趨勢。
- 七、中國大陸提案建議主辦明(2018)年第二次 APEC PPSTI Centers Meeting,將由 PPSTI Technology Transfer Center 辦理,時間暫定於 2018 年兩次 PPSTI 會議之間,後續確認後將透過 APEC 秘書處轉知各中心指派代表參與。

九、 分組結論報告:

本次分組報告進行方式除了各計畫或中心進行執行進度報告與討論,亦針對如何促進各計畫或中心之成果交流、提出政策建議等進行討論,並將各分組結論於大會上分享。

行討論。分組 A 各計畫分別如下:

ACABT 於今年舉辦 APEC YES-Challenge 競賽活動,APEC 地區共有 29 隊報名參加,經激烈初審與複審,預計於今年 8 月底於逢甲大學進行決賽及頒獎典禮。分組會議中有美國代表建議,為促進各計畫或中心之成果交流分享,或可考慮將 YES-Challenge 擴大成為定期舉辦之活動,並取得 APEC 其他會員體同意將其頒獎典禮提到 PPSTI 大會上,仿美國 APEC ASPIRE 之方式在 PPSTI 晚宴上頒獎。

- 十、本次會議於第二天上午進行創新政策分享研討會(Innovation Policy Sharing Seminar),各會員體代表針對「Communicating Science to the Public」進行分享。本部周世傑司長在此會議中亦就加強鼓勵創新、促進產學合作、以及本部所推動之相關促進產學鏈結、產學合作方案及辦法進行報告分享,並獲得許多會員體熱烈反應及迴響,紛紛表達高度之合作意願。

十一、 巴布亞紐幾內亞報告 PPSTI 11 辦理方式:

PPSTI 11 預計將於本明年於巴布亞紐幾內亞首都莫士比港(Port Moresby) 舉行,議程及相關行政安排等事宜,將另由 APEC 秘書處轉告週知。

參、後續我方應配合辦理之工作

- 1. APEC Funding Session II 將於 6 月 21 日截止收件,將與我方提案單位—財團法人紡織綜合發展研究所及逢甲大學綠能中心(ACABT) —協力完成 concept note 提案作業,同時每案須獲得至少 2 個會員體同意 co-sponsor。
- 2. APEC PPSTI 官方網站已上線,請 APEC Centers 代表及各項 PPSTI 計畫 Project Overseer (PO)將活動相關資訊及中心年報提供予 APEC 秘書處。

肆、結論與建議

- 1. 有鑒於兩岸情勢敏感,建議我方各單位後續準備各項書面資料時,需特別注意符合 APEC 慣例原則,提及我方時應使用 Chinese Taipei,避免使用具有主權國家涵義之字眼如 nation、national、country等,以免不必要之爭議。
- 2. 本年度 PPSTI 會議業於上半年辦理完成,建議針對明(2018)年之 PPSTI 規劃,例如是否爭取來台辦理 1 場 PPSTI 會議等議題應及早進行研議,以利提早徵求各會員體意見。
- 3. 考量本次會議有許多會員體代表(如加拿大、澳洲等)建議,PPSTI 應成立 PPSTI Board Committee,以 Top-down 模式、策略性的指定年度提案主題。故建議我方後續提案策略,應以較宏觀之角度綜整規劃整合性之議題。
