1. THE COMMITTEE ON SUBSIDIES AND COUNTERVAILING MEASURES WILL HOLD A SPECIAL MEETING ON TUESDAY, 27 OCTOBER 2020 AT 10.00 A.M. IN THE CENTRE WILLIAM RAPPARD. THE PURPOSE OF THIS SPECIAL MEETING IS TO CONTINUE THE COMMITTEE'S REVIEW OF NEW AND FULL SUBSIDY NOTIFICATIONS.
