Introduction

- Effective prevention and control of animal diseases, and veterinary public health depends first of all upon policies of good veterinary governance.
- It is acknowledged worldwide that the use of VMPs must be strictly supervised for, in absences of controls, the risks associated with their imprudent use may exceed any potential benefit.
- E-certificate is very crucial in veterinary service.

Case 1: *Importation of VMPs*

The authorisation to import, manufacturing, distribution and use of veterinary medicinal products VMPs (vaccines, veterinary medicines, such as antimicrobial agents, and diagnostic kits.) through the veterinary legislation is an essential work of the VS.

The control of VMPs begins with legal adopted definitions and regulations governing the importation, manufacture and distribution at national level.

Case 1: *Importation of VMPs*

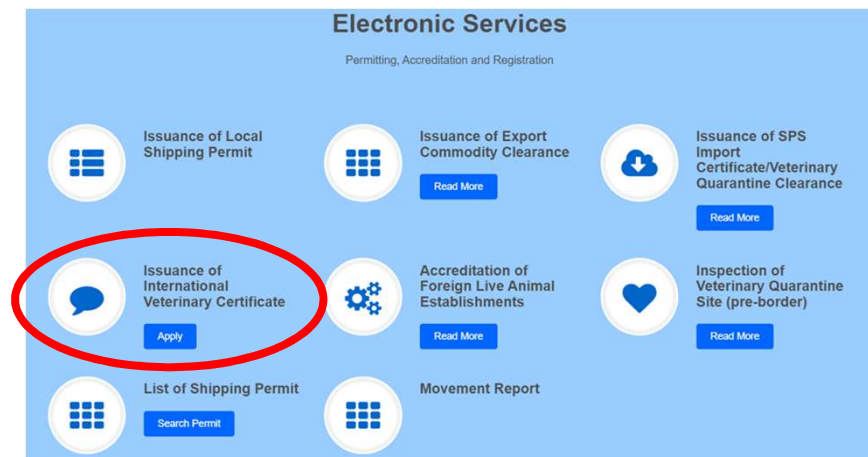
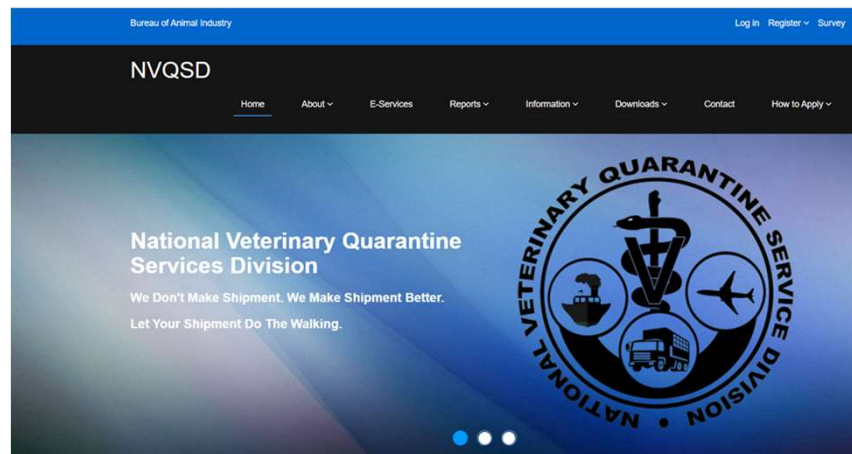
Except for the registration process, veterinary medicines imported into the country are subject to all regulatory and administrative control applicable to human medicines.

Application to import veterinary medicines must be accompanied by their relevant Technical Data Sheet ,certificate of free sales or market authorisation ,GMP certificate , approval /registration by the Regulatory Authority of the country of origin.

Approval from the VS is required for the issue of the import authorisation by the Pharmacy Board.

However due to interministerial difference in opinions and the reluctance to delegate the duties & responsibilities of the REGULATORY UNIT to the VS , monitoring is difficult .

Issues/Concern:

- The system is not user-friendly

- Additional requirements aside from the VHC/IVC (ex: rabies titer test, official endorsement from the competent veterinary authority, certificate of non-COVID exposure)

 - Human

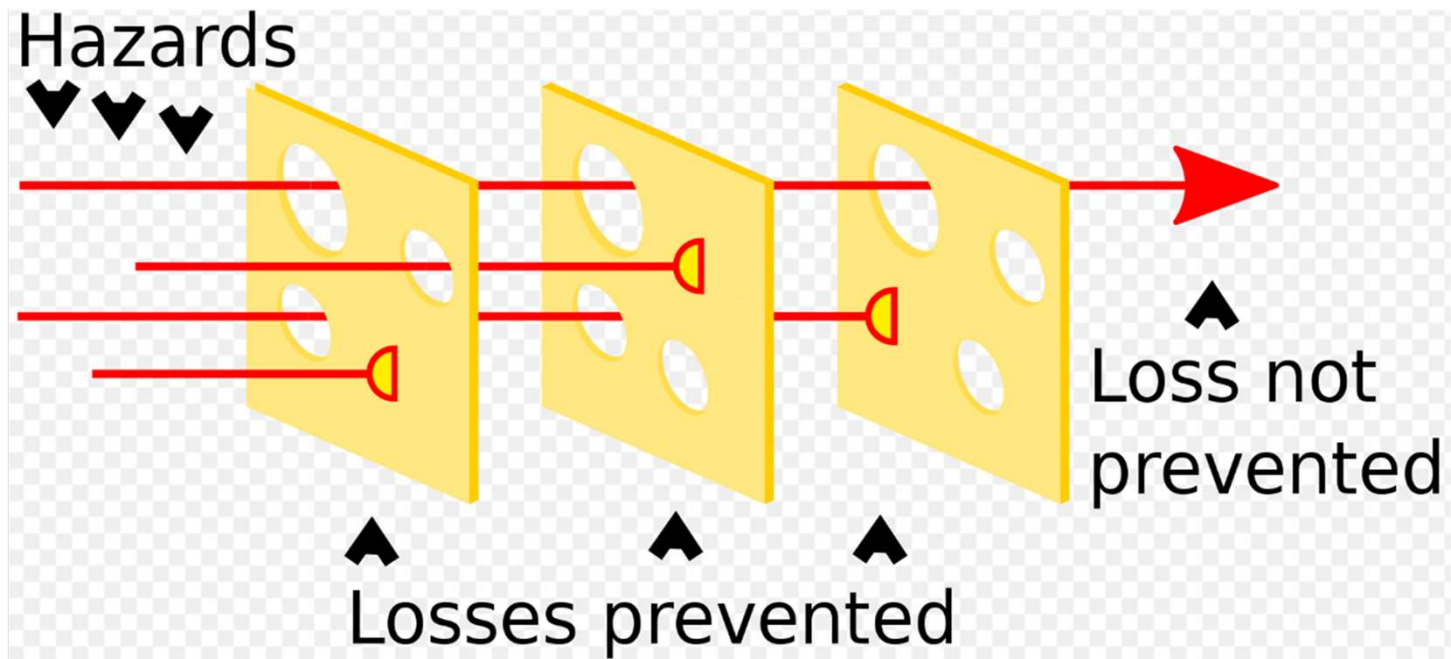


Case 2: Online issuance of Veterinary Health Certificate (VHC) for export of dogs and cats

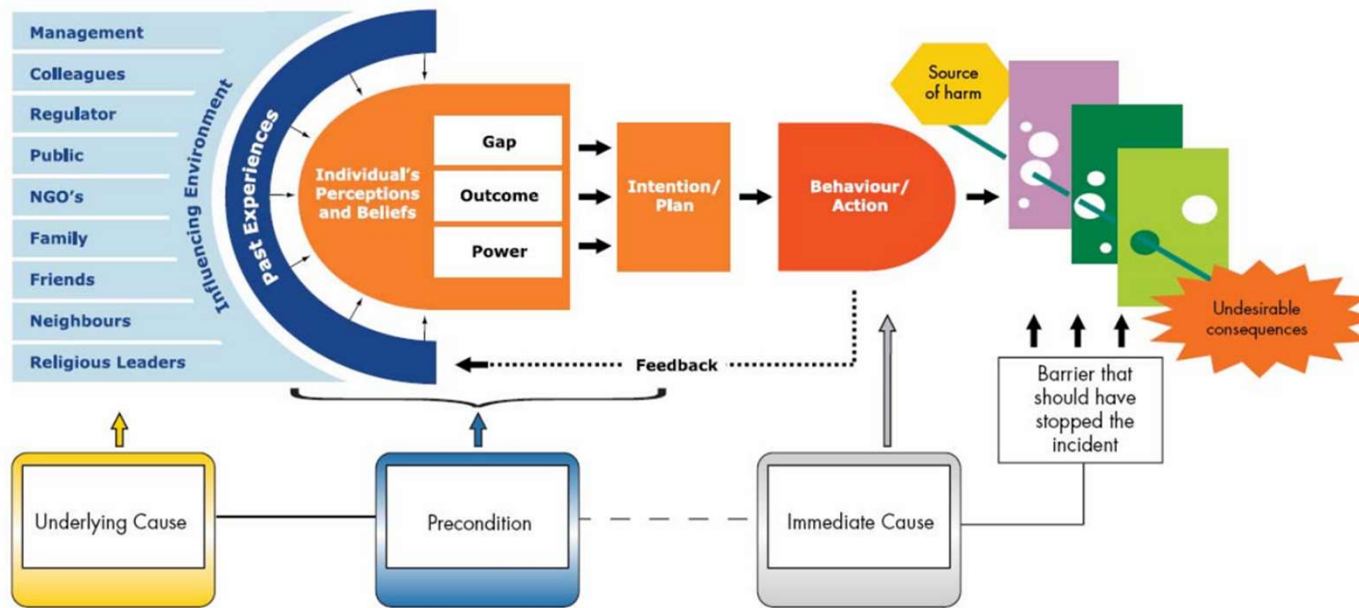
End result

6. Identify and track success measures regularly

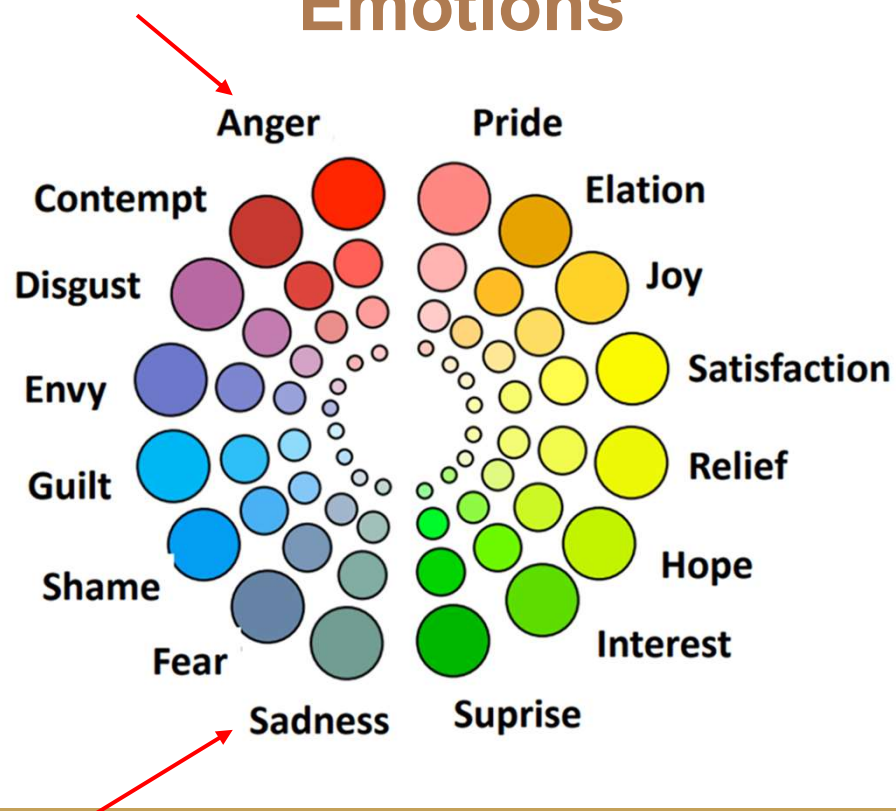
Analysis of cases: Strategic Planning

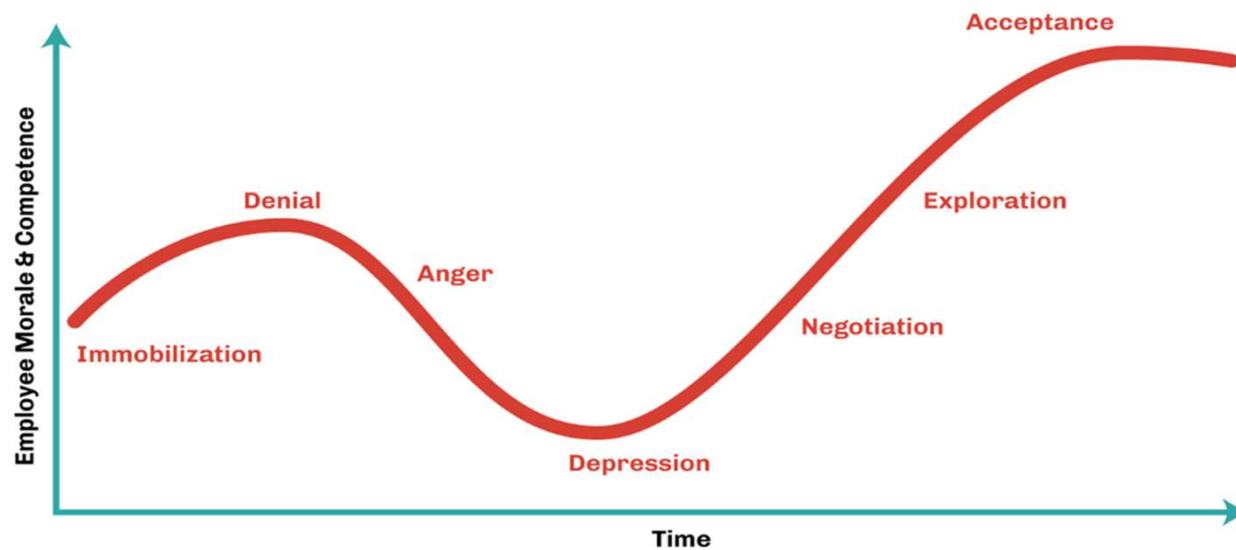

National

Establishment of a National Medicines Regulatory Agency

Special provisions for VMPs in the ANIMAL DISEASE ACT and set up a Product Registration Committee for veterinary medicinal products.

International

To establish a safe and effective veterinary medicinal products use across the world through wider international harmonisation of technical requirements for the registration and guidelines for veterinary medicinal products
