Tax Revenue Impacts from COVID-19 (1/2)

Adjust the Tax Amount based on the Actual Business

Unit: US\$ million

Business Tax	Sales amount reassessed	21.40
House Tax	Tax rate cut for stoppage of operation	20.57
Vehicle License Tax	Tax exemption while out of service	93.43
Amusement Tax	Tax deduction for stoppage of operation or use	18.30

From January 15th, 2020 to August 31st, 2022

✓ Approved cases: 90,675


✓ Tax payment: US\$3.95 billion





Tax Revenue Impacts from COVID-19 (2/2)

☐ The total tax revenue has grown steadily recently



Note: In 2022, the cumulative January to August was US\$ 75.36 billion, US\$10.83 billion (+16.8%) more than the same period last year.


