## Asia-Pacific Network for Sustainable Forest Management and Rehabilitation Financial Status Analysis Presentation 2022 (Unit: KUSD)

### **Annual Program Funding Source**

In 2022, APFNet performed all work in compliance with the accounting policies which were approved by the Board of Directors (Decision B. 02/05), and the funds were allocated reasonably to ensure the development and implementation of events and activities. We conducted 40 projects in 2022, and the input was RMB18,310K (USD 2,796K), among which, the funding amounted RMB 11,208K (USD 1,709K) was from the Chinese government, and matching fund of RMB 7,102K (USD 1,087K) was contributed by partners.

APFNet kept active communication and broad cooperation with international organizations, forestry universities, forestry research institutes, local forestry bureaus, farms and charity, etc. In 2022, 23 projects were implemented with 19 partners, who provided financial and technical support. The cooperation with a Chinese foundation, a charity, is a new initiative to explore way of funds diversity.

#### 1. Income:

Income includes donation and interest income. The donation was from the Chinese government.

# 2. Expenses:

## (a) Program expenses:

Program expenses contributed RMB 11,208K (USD 1,709K), accounting for 44% of total expenses in 2022 and decreased by RMB 8,832K (USD 1,361K) compared to 2021. Program expenses were allocated by four key pillars and seven sub regions, according to Strategic Plan.

From the perspective of the four key pillars, the main expenditures were demonstration projects, with a total amount of RMB 8,900K (USD 1,357K) in 2022, accounting for 79% of the total program expenses. 24 projects were carried out in 2022, mainly included: "Demonstration of vegetation restoration and management and utilization of forest resources in the Greater Central Asia (Chifeng site) Phase II", "Construction of Multifunctional Forest Management Demonstration Sites - Phase III" and "Establishment of a High Value Tree Species Breeding Center in Cambodia".

**Geographically,** the main expenditures were occurred in the Great Central Asia and the Greater Mekong Sub-region. In 2022, the Greater Central Asia expenditure amounted to RMB 3,909K (USD 596K), accounting for 35% of the total program expenses, and Greater Mekong Sub-region expenditure amounted to RMB 3,467K (USD 529K), accounting for 31% of the total program expenses, of which:

- Regarding the Great Central Asia sub-region, the main projects were "Demonstration of vegetation restoration and management and utilization of forest resources in the Greater Central Asia (Chifeng site) Phase II" and "Construction of Multifunctional Forest Management Demonstration Sites Phase III".
- Regarding the Greater Mekong Sub-region, the main project was "Establishment of a High Value Tree Species Breeding Center in Cambodia".

#### (b) Management expenses:

Administrative expenses amount to RMB 13,758K (USD 2,097K), including Human Resources, Administration, Evaluation, Planning and Review, the Board and the Council Expense and Partnership Network, etc., of which:

- The cost of human resources was composed of the expenditure on salary, welfare, staff capacity building, amounting to RMB 9,261K (USD 1,412K).
- Administrative expenses was composed of the expenditure on rent and operations, depreciation and amortization, agency, urban transportation, amounting to RMB 4,410K (USD 672K).
